- 3. That the amounts of the above recommendations, illustrated within this report, be funded by Capital Budget Project No. EN-1940-13, including all contingency allowances, administration recovery fees and applicable taxes; and
- 4. That the Mayor and City Clerk be authorized to sign the appropriate documents.


