AWARD OF TENDER T17-025 2017 ROAD REHABILITATION – VARIOUS ROADS (EAST VAUGHAN) WARD 4, 5

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Deputy City Manager of Public Works and the Director of Infrastructure Delivery, dated April 4, 2017:

The Deputy City Manager of Public Works and the Director of Infrastructure Delivery, in consultation with Director of Procurement Services and Director of Financial Planning & Development Finance and Deputy City Treasurer recommend:

- 1. That the contract for Tender T17-025, 2017 Road Rehabilitation Various Roads (East Vaughan), be awarded to Furfari Paving Co. Ltd, in the amount of \$1,437,226.00, plus applicable taxes;
- 2. That a contingency allowance in the amount of \$144,000.00 plus applicable taxes, be approved within which the Deputy City Manager of Public Works or his designate is authorized to approve amendments to the contract;
- 3. That a Geotechnical Allowance and Material Testing in the amount of \$30,000.00 plus applicable taxes, be approved to ensure compliance with all applicable standards:
- 4. That the amounts identified in the above recommendations, including all contingency allowances, applicable taxes and administration recovery, be funded from Capital Project CD-2018-15, 2017 Road Rehabilitation; and
- 5. That the Mayor and City Clerk be authorized to sign the appropriate documents.

Contribution to Sustainability

An integral part of a sustainable city is effective asset management. Through infrastructure investments, the risk of failure is reduced and system reliability improved, providing optimal service to residents while managing our infrastructure assets at the lowest life cycle cost. The proposed rehabilitation of these roads will maximize the return on the City's Capital and operating investments and ensure that an acceptable level of service is maintained for the health and well-being of its citizens.

The rehabilitation of the existing roads incorporates recycled asphalt material within the new asphalt pavement. This is consistent with Green Direction Vaughan Goal #1: To significantly reduce our use of natural resources and the amount of waste we generate, in particular Objective 1.1 to reduce greenhouse gas emissions and move towards carbon neutrality for the City of Vaughan's facilities and infrastructure.

Economic Impact

The cost in the amount of \$1,669,587.96 which includes construction, contingencies and the appropriate administration costs and applicable taxes can be funded from the approved Capital Project CD-2018-15, 2017 Road Rehabilitation/Reconstruction as illustrated below:
