On March 23, 2017, York Region Council received a revised draft 2017 Development Charge Background Study and proposed Bylaw. York Region Council will also hold an additional public meeting on April 20, 2017, with the intent of approving the 2017 Development Charge Bylaw at their meeting on May 25, 2017.

There are a number of changes in the revised draft 2017 Development Charges Background Study that will assist in providing the needed infrastructure in the City of Vaughan to accommodate growth. However, a gap remains between the needed infrastructure and the infrastructure that will be provided by York Region based on the draft 2017 Development Charges Background Study.

To further discuss these concerns, Mayor Bevilacqua, York Region Chairman and CEO Wayne Emmerson, Regional Councillors and staff are scheduled to meet on April 6, 2017. Following this meeting, staff will report to Council at their meeting on April 19, 2017, summarizing the detailed review of the York Region revised draft 2017 Development Charge Background Study and Bylaw.
