Regional staff and its surveyors are responsible for data collection, verification and data integrity. Each year between May and August, Region staff conducts door-to-door interviews.

During the collection process, businesses are advised that the data related to number of employee, i.e., full-time; part-time; full-time off-site; part-time off-site; seasonal on-site; and seasonal off-site; will be kept confidential. Consent for the data's use is given by the businesses to York Region at the time of collection on the basis that the data is used for internal purposes and only published in aggregate form.

The Region of York will be updating the YRES, its data and survey methodology for 2013, and it is anticipated that a new signed partnership agreement, including any confidentiality stipulations, will be required of municipal and regional partners in the fall of 2013.
