EXTRACT FROM COUNCIL MEETING MINUTES OF APRIL 21, 2015

Item 28, Report No. 17, of the Committee of the Whole, which was adopted, as amended, by the Council of the City of Vaughan on April 21, 2015, as follows:

By approving the recommendation in Communication C14 from the Interim City Manager, the Director of Building & Facilities and the Chief of Vaughan Fire and Rescue Services, dated April 10, 2015, as follows:

- 1. That Tender T15-069 for the Renovations and Expansion of Fire Station #75 be awarded to Samson Management, in the amount of \$489,000.00 (inclusive of the alternative price items), plus applicable taxes;***
- 2. That a 20% project contingency allowance in the amount of \$97,800.00 be approved within which the Interim City Manager, or designate, is authorized to approve amendments to the contracts within this project;***
- 3. That the capital project budget of FR-3599-13 be increased by \$222,000.00, to be funded from the Fire Equipment Replacement Reserve;***
- 4. That the total tender and contingency amounts be funded from the increased capital project budget of FR-3599-13;***
- 5. That the inclusion of this matter on a Public Committee or Council agenda with respect to increasing the capital budget for FR-3599-13, Tender Award T15-069 - Renovations and Expansion of Fire Station #75 is deemed sufficient notice pursuant to Section 2(1)(c) of ByLaw 394-2002 as amended; and***
- 6. That the Mayor and City Clerk be authorized to sign the necessary documents.***

**TENDER AWARD T15-069 - RENOVATIONS AND EXPANSION OF FIRE STATION #75

At the Committee of the Whole meeting of April 14, 2015 staff recommended that Tender Award T15-069 – Renovations and Expansion of Fire Station #75 be provided at the Council Meeting of April 21, 2015.

Recommendation

The Interim City Manager, the Director of Building & Facilities and the Chief of Vaughan Fire and Rescue Services (VFRS), in consultation with the Director of Financial Planning & Analytics, the Director of Purchasing Services and the Manager of Building Construction, recommend:

1. That Tender T15-069 for the Renovations and Expansion of Fire Station #75 be awarded to Samson Management, in the amount of \$489,000.00 (inclusive of the alternative price items), plus applicable taxes; and,
2. That a 20% project contingency allowance in the amount of \$97,800.00 be approved within which the Interim City Manager, or designate, is authorized to approve amendments to the contracts within this project; and,

Economic Impact

At the January 13, 2015, Committee of the Whole meeting, Report No. 2, Item 16, staff advised that based on an analysis of the scope of work that is required for VFRS to provide emergency services to the community from Fire Station 7-5, additional funding in the order of \$250,000.00 will be required to complete this project.

In accordance with this estimate, additional funding of \$222,000.00 is now required to supplement approved capital project FR-3599-13, for the purpose of awarding tender T15-069 including a 20% project contingency. A 20% project contingency is recommended for this renovation/expansion project because of the need to renovate, and connect new construction to an existing building. This type of project has more inherent risks than greenfield construction and without an adequate contingency to address possible unknown conditions within the existing building, project risk increases considerably. Funding is available within the Fire Equipment Replacement Reserve to accommodate the additional funding request.

The purpose of this report is to obtain Council approval to increase the budget of capital project FR-3599-13 and to award Tender T15-069 to Samson Management.

Background - Analysis and Options

Purchasing Services advertised Tender T15-069 on Bids & Tenders, Biddingo, OPBA and DCN on March 4, 2015 with an original closing date of March 19, 2015. Three (3) Addenda were issued to answer questions received and to extend the closing date to March 26, 2015.

Twenty-four (24) potential bidders picked up the Tender Documents. Twelve (12) bids were received from the following bidders:

The lowest bidder, at \$439,000.00, is Samson Management. In addition to the bid price, the total cost of two (2) alternative price items, Fire Alarm System & Existing Roof Replacement, is \$50,000.00. As the alternative price items provide good value for cost, they are incorporated into an overall Tender award of \$489,000.00. Additional award amounts are: contingency, administration fees and applicable tax, and are detailed in the Financial Summary table below:


