FIREWORKS DISPLAY PERMITS

The Committee of the Whole recommends approval of the recommendation contained in the following report of the City Clerk, dated April 14, 2015:

Recommendation

The City Clerk in consultation with the Manager of Special Projects, Licensing and Permits, Director of By-Law and Compliance and the Deputy Fire Chief recommends:

1. That Display Firework permits issued for 2015 contain a time restriction prohibiting fireworks discharge after 10:00 p.m. except for Canada Day and Victoria Day when detonation will be permitted until 11:00 p.m.

Contribution to Sustainability

By introducing a time limit of 10:00 p.m. the City will be balancing the interest of persons wishing to set off display fireworks while at the same time protecting the City's residents from excessive noise late in the night.

Economic Impact

The adoption of the recommendation will have no financial impact to the City.

Communications Plan

The Fire Department, subject to Council's approval of the above recommendation, will be amending the fireworks display permit application to reflect the amended time for the detonation of display fireworks to no later than 10:00 p.m. generally, and to no later than 11:00 p.m. for Canada Day and Victoria Day.

Purpose

The purpose of this report is to respond to Council's request that a report be brought forward to review the issuance of fireworks display permits, especially in relation to applications in close proximity to residential areas.

Background - Analysis and Options

By its adoption of Item 25 of Report No. 2 of the Committee of the Whole of January 20, 2015, Council directed that a report be brought forward to review the issuance of fireworks display permits in relation to applications close to residential areas.

At present, By-Law 124-98, the Fireworks By-law, does not impose time of day restrictions on the discharge of fireworks.

Display permits which are issued by the City's Fire Department restrict the discharge of fireworks to no later than 11:00 p.m. in accordance with the City's Noise By-Law, 96-2006, as amended, which prohibits any detonation of fireworks or explosives after 11:00 p.m. Approximately 45 permits were issued in 2014.

As the City becomes more urbanized the noise generated from the discharge of fireworks becomes more of an issue within residential areas. In consultation with the Deputy Fire Chief and the Director of By-Law and Compliance, it was determined that adjusting the general end time for fireworks displays would balance the needs of groups wishing to have fireworks displays at their events while at the same time protecting the quiet enjoyment of residents in their homes. It is therefore being recommended that display permits issued for 2015 contain a restriction that fireworks cannot be discharged after 10:00 p.m. except for Canada Day and Victoria Day when permits will be issued up until 11:00 p.m.

The exceptions for Canada Day and Victoria Day are considered to be reasonable given the status of these statutory holidays. Further, there is no significant history of complaints associated with fireworks displays to 11:00 p.m. on those holidays.

I would like to submit a communication regarding the fireworks recommendation for the Council meeting for April 21. My name is Andrea [REDACTED] and I live at Bathurst and Rutherford. I am one of the residents who complained about the noise of the fireworks coming from Eagles Nest Golf Club, which occur almost weekly throughout May-September. It is my understanding that a recommendation has been put forth to only allow fireworks to occur up until 10 PM rather than the current time of 11 PM (except on Victoria day and Canada day). While I appreciate this recommendation, it does not solve the concern of fireworks waking up the kids in the surrounding neighbourhoods. The neighbourhoods surrounding Eagles Nest Golf Club consist of many young families with young kids who go to bed before 10 PM. Therefore, I am asking if the time for when fireworks can occur until can be made earlier or ideally if permits can no longer be given out for fireworks that do not occur on Victoria day and Canada day.
