- On June 7, 2015, the DANI Centre will be performing an "Alice in Wonderland" play featuring adults with accessibility challenges. The play will be held at Vellore Community Centre.

The barriers people with disabilities face are more prevalent as a result of the environment in which they live in, rather than their impairment. Obstacles to participation stem more from the environment in which people live than from within the individual's perception of their abilities. These barriers can be prevented, reduced or eliminated.

The inclusivity of citizens with disabilities is a corporate-wide vision shared by Vaughan Council and staff as identified in Vaughan's corporate strategic plan. The City plays an important role in ensuring access for residents with disabilities and through the Vaughan Accessibility Advisory Committee (VAAC).
