Purchasing Services advertised the tender on the Ontario Public Buyers Association and the Bidingo and on the City Web Page on April 11, 2013 with an original closing date of April 17, 2015. A mandatory site meeting was held at the Joint Operations Centre, 2800 Rutherford Road, Vaughan, on April 10, 2015. One addendum was issued to answer questions received and to extend the closing date to April 21, 2015.

Seven (7) proponents attended the mandatory site meeting. Four (4) bids were received on closing. Staff is currently in the process of evaluating the tender submissions.

The Transportation Services, Parks and Forestry Operations Department administers the removal of dead trees due to disease, insects or storm damage (including the stumps) and also replants trees on public lands throughout the City of Vaughan.

The number of trees identified in this tender is 3,840. The trees are identified for planting in 2013 and 2014. The lowest bid price, submitted by M&S Architectural Ltd., was \$1,822,286.37 (excluding HST and administrative recovery). Funds for Tender T15-111 for the Supply and Planting of Trees throughout the City of Vaughan were approved in both the 2014 and 2015 Capital Budgets.

Sufficient funding to cover the Tender T15-111, Supply and Planting of Trees is budgeted for under the 2015 Capital Budget and remaining funds from previous years' Capital Budgets.

The supplying and planting of trees (including other accompanying activities) will be funded from the following Capital Projects: PO-6700-10 Tree Planting Program; RP-6700-15 Tree Planting Regular; RP-6757-15 Tree Planting Regular Added; PO-6739-13 Tree Replacement Program EAB; RP-6739-15 Tree Planting Program EAB; and RP-6755-15 Ice Storm Tree Replacement. A contingency of 10% of the bid price has been included in the budget to account for unanticipated expenses.

Parks and Forestry staff, in conjunction with Purchasing Services met with M&S Architectural Ltd. on April 28, 2015 and discussed the proponent's project plan, and operational preparations to the satisfaction of the City. References endorsed the company's tender during interviews on May 6 and 7, 2015. The significant variance between the successful and the next bidder could be attributed to the proponent being a new entry to the tree planting program.
