REQUEST FOR SERVICES IN KIND BY YORK REGIONAL POLICE

Whereas, York Regional Police in partnership with Catholic Community Services of York Region will be hosting the York Region Community Cup Soccer Tournament 2013, a non-profit event to support new immigrants from Vaughan and York Region with an expected attendance of over 300 people; and

Whereas, the City of Vaughan has received the special events permit application from York Regional Police for the Community Cup Soccer Tournament to take place on Sunday June 1, 2013 at Mackenzie Glen Park – 220 Cranston Park Ave in Maple; and

Whereas, YRP has submitted a letter requesting the amount of \$1554.39 being the cost of the rental for the use of the field and other City services be waived; and

Whereas, a decision by Council on this matter on June 4, 2013 provides insufficient time for the issuance of the necessary permits and permissions;

It is therefore recommended that:

- 1)** that in the spirit of continued partnership and cooperation between City of Vaughan and York Regional Police, that the City of Vaughan waive rental costs and fees for this special one-time community event as a gesture of goodwill with such costs offered as services in kind by the City of Vaughan, to an upset limit of \$1554.39; and
- 2)** that Council ratify any action taken prior to its consideration of this matter at its meeting of June 4, 2013


