

AWARD OF TENDER T13-089 HERITAGE PARK – WARD 4

Recommendation



The Commissioner of Community Services, in consultation with the Directors of Parks Operations and Forestry, Purchasing Services, Legal Services and Budgeting and Financial Planning, recommends:

- 1) That Tender T13-089 for Heritage Park Neighbourhood Park Development be awarded to Pine Valley Enterprises in the amount of \$448,592.00 plus applicable taxes; and,
- 2) That provisional items 1 to 4 be awarded in the amount of \$38,145.18 plus applicable taxes; and,
- That a 15% contingency in the amount of \$73,010.58, plus applicable taxes, be approved, within which Parks Development is authorized to approve amendments to the contract; and,
- 4) That the Mayor and City Clerk be authorized to sign the appropriate documents.

Purpose

The purpose of this report is to seek Council approval to award Tender T13-089 for Heritage Park to Pine Valley Enterprises.

Background - Analysis and Options

The project is a new neighbourhood park located at 631 Valley Vista Drive, Ward 4 in Block 11 which includes a junior and senior playground, pedestrian pathways, pathway lighting, a shade structure, exercise equipment and planting areas. Provisional items being added will mean the addition of a secondary shade shelter as requested by the public at the Open House as well as turf stone pavers in the boulevard and an infiltration trench to minimize storm water runoff.

This project will provide a new neighbourhood park in a rapidly growing and established community.

All seven (7) prequalified general contractors were invited to provide bids for Tender T13-089 and were notified that the tender would close and be publicly opened on May 10, 2013. Four (4) prequalified bidders picked up the tender packages and two (2) bids were received as follows:

Expenses and commitments to date include: geotechnical consulting fees, electrical and storm water engineering consulting services, surveying and mobile sign costs. Parks Development staff have reviewed the submitted bids and confirm that the low bidder meets the requirements of the bid documents. Therefore, it is appropriate to award this contract to Pine Valley Enterprises.

A total contingency amount of 15% of the bid price (\$73,010.58) is requested, covered within the approved capital budget, and will be used to address any unforeseen work in completing the scope of this project. There are some potential issues related to the finalization of the storm water certification and also the related geotechnical requirements. If there are residual funds following completion and deficiencies being resolved, we will recommend the project for closure and the funds can be returned to the original source.
