"THAT staff be directed to utilize the financial strategies contained in the Vaughan City-Wide Streetscape Implementation Manual and Financial Strategy to evaluate each proposed streetscape enhancement project with the goal of maximizing developer contributions or other growth related funding sources, while minimizing property tax impacts."

The Vaughan City-Wide Streetscape Implementation Manual and Financial Strategy provides a standard streetscape classification system and a streetscape costing model that will be utilized for the design and budgeting of this Plan, including capital, operations and maintenance, and replacement costs.

Communications Plan

The Woodbridge Heritage District Urban Design Streetscape Plan will be used as a tool by the City, development community, and stakeholders to guide design development of public and private realm development projects within the study area boundaries. The Consultant will be required to develop and implement a consultation strategy for inclusive and meaningful public, external agencies and stakeholder participation throughout the study process, and to provide instruction on the use and application of the guidelines. A Technical Advisory Committee will be established to facilitate input from key municipal and regional departments, and public agencies. All agenda items and minutes relating to Heritage Vaughan Committee meetings, the Statutory Advisory Committee to Council on heritage matters, are circulated to relevant City departments, applicants and their representatives. A project webpage will be created for the City website to communicate project information and updates to the public.

The RFP package provided details of the contract, including the evaluation criteria used in the assessment of competing proposal bids. One (1) Addendum was issued on April 30, 2015 to answer questions from the Proponents. Fourteen (14) Plan Takers picked up/downloaded the Bid Documents and six (6) submissions were received from the following Proponents:

An Evaluation Committee, comprised of staff from Development Planning, Development Engineering and Infrastructure Planning Services, Parks Development, and Capital Delivery and Asset Management, and facilitated by the Purchasing Services Department, carried out the evaluation process. Each proposal was evaluated based on the capability, experience, expertise, and skills of the team members, and in terms of suitability with respect to team organization, project management, and quality of its written presentation. DIALOG Ontario Inc. was the highest scorer.


