<u>Purpose</u>

The purpose of this report is to provide Council with an update on TransCanada's proposed King's North Connection Project.

Background - Analysis and Options

TransCanada Corporation proposed a new pipeline through Vaughan called the King's North Connection Project.

TransCanada Corporation is proposing to construct a new natural gas pipeline within the cities of Brampton, Toronto and Vaughan, known as the King's North Connection project. (Refer to Attachment No. 1). The proposed pipeline will be 900mm in diameter and approximately 13km in length. The proposed route is planned to be constructed within a new right of way following the existing and proposed Highway 427 (in part).

The King's North Connection project is designed to connect the new natural gas facilities proposed by Enbridge Inc. (as part of the GTA project) with TransCanada's existing pipeline infrastructure.



Subject: TransCanada's Proposed King's North Connection Project – Vaughan Council Follow-Up

TransCanada is appreciative of the opportunity to have presented to the Committee of the Whole on March 4, 2014 regarding our proposed pipeline development. TransCanada would like to take this opportunity to clarify and elaborate upon the ongoing regulatory process as it relates to Motions 1 through 3 approved by Council March 18, 2014 (Motions).

As outlined within the presentation provided to Council, TransCanada will file a Section 58 application with its regulator, the National Energy Board (NEB), in Q3 of 2014. As part of that application, and in accordance with the *National Energy Board Act* and Filing Manual, TransCanada is required to complete and file an Environmental and Socio-Economic Assessment (ESA).

Pursuant to its jurisdiction over the pipeline and mandate under the *National Energy Board Act*, the NEB will assess the environmental and socio-economic effects of the project as set out in the ESA as well as any submissions made with respect to the ESA or its findings. The NEB will conduct that assessment prior to making a decision or recommendation on whether or not to approve the application.

The ESA is a comprehensive analysis that, amongst other things, describes the predicted beneficial and adverse effects of Project on the biophysical and socio-economic environment and defines proposed mitigations within a defined study area. The ESA will consider and address the information described in the Motions, namely:

- project interactions with publicly available land use and resource plans identified within the project study area
- the effects of the project on the socio-economic and biophysical environment over the life of the project, including project construction, operation, maintenance, decommissioning and abandonment
- the potential effects of the environment (such as weather) on the project
- the potential effects resulting from possible accidents and malfunctions, as well as potential
 cumulative effects from other projects in the vicinity.

The ESA will also include an Environmental Protection Plan, which outlines mitigation measures that may be required to address any potential environmental effects identified in the ESA.

TransCanada is currently in the process of collecting and compiling information required for its ESA in accordance with its processes, seasonal windows and accepted methodologies of relevant environmental authorities. As a result of this ongoing process, TransCanada will not be in a position to provide the City of Vaughan with reports of the requested information prior to filling the ESA with the NEB with its Section 58 application.

TransCanada will provide the City of Vaughan with a copy of its filed Section 58 application, which will include the ESA as well as a summary and response to comments and concerns that have been provided to TransCanada as part of its engagement to date. In the event there are additional concerns about the project and/or the application and its contents at that time, the City of Vaughan is invited to contact TransCanada or provide comments directly to the NEB. We have attached an NEB brochure with more information on how to participate in the NEB process.

We trust that this additional information clarifying the regulatory process and requirements will be of assistance.
