The Commissioner of Legal & Administrative Services/City Solicitor and the Director of By-law & Compliance recommend:

- 1) That the Regional Municipality of York (and their agents) be granted a noise exemption, in accordance with the City's Noise By-law 96-2006, for the purposes of road reconstruction (including traffic staging; mobilization and demobilization; equipment and material delivery; relocation of temporary concrete barriers; pavement marking/painting; pavement removal; and paving of Highway 427 from 0.5 km south of Highway 7 to Zenway Boulevard) for the period of August 5, 2014 through October 1, 2014.
- 2) That this request for noise exemption be granted with the following conditions:
 - a) That notices be sent to surrounding businesses within a 60 metre radius, in keeping with City standards, advising them of the impending work;
 - b) That the notice to businesses include contact information for contractors conducting the work;
 - c) That no construction take place on Saturdays or Statutory Holidays; and
 - d) That no construction take place on Sundays prior to 7:00pm.

Purpose

The purpose of this report is to seek Council's approval in support of an Application for Exemption to the City's Noise By-law 96-2006 from the Regional Municipality of York – TCP Department-Roads ("Applicant"), in support of the necessary municipal/regional work, proposed to take place from August 5, 2014 through October 1, 2014. As this request for granting an exemption to the provisions of the City of Vaughan Noise By-law exceeds staff's delegated authority of a maximum of eleven calendar days, authorization for exemption of the time proposed requires the approval of City Council.

Background - Analysis and Options

The City of Vaughan Noise By-law 96-2006 prohibits noise created from the use of "construction equipment" as defined, between the hours of 7:00pm of one day to 7:00am the following day and on Sundays or statutory holidays.

Any noise created by construction activity during these prescribed hours requires an exemption to the provisions of the By-law. Exemption requests for construction noise are governed by the provisions of Section 19 Exemption – Construction.

On April 24, 2014, the Applicant submitted a written request (Attachment No. 1) to the City of Vaughan, By-law & Compliance Department, requesting an exemption to the Noise By-law for the purposes of Highway 427 road reconstruction, between Highway 7 and Zenway Boulevard, Contract No. 14-185. The proposed road reconstruction includes traffic staging; mobilization and demobilization; equipment and material delivery; relocation of temporary concrete barriers; pavement marking/painting; pavement removal; and paving.

The construction is primarily located in areas zoned commercial and industrial and is scheduled to take place in two phases.

Phase 1

The first phase of the project will include the closure of northbound Highway 427, between Highway 7 and Zenway Boulevard. During this closure, the contractor will complete the removal of existing pavement and resurfacing the area. This phase of the project should be completed before August 31, 2014.

Phase 2

The latter half of the project (Phase 2) will include the closure of southbound Highway 427 between Zenway Boulevard and Highway 7. During this portion of the closure, the contractor will be removing pavement and resurfacing the area. The 2nd phase of the project should be completed before September 30, 2014.

As described within the Application documents, construction activity is required during prohibited evening hours to accelerate construction for the following purposes:

- Layout traffic staging;
- · Mobilization and demobilization;
- Material and equipment delivery;
- · Relocation of temporary concrete barriers;

- Pavement marking painting;
- Pavement removal; and

The work being conducted after hours (i.e. between 7:00pm - 7:00am) will only be executed Sunday evening through Friday (and will not include Saturdays or statutory holidays). Commencement of work on Sundays will occur in the evening only with a start time of 7:00pm or later.

A written Notification of Road Construction will be provided to surrounding residents and businesses prior to commencement of construction (Attachment No. 2).

Scope

Grading, Gravelling, Hot Mix Asphalt Paving, Traffic Control and Drainage Works.

Location

Highway 427 from 0.5 km south of Highway 7 to Zenway Boulevard in the City of Vaughan

<u>Time</u>

Sunday at 8:00pm – Friday at 7:00am. August 5, 2014 to September 30, 2014

Work Detail

Highway 427 northbound between Highway 7 and Zenway Blvd. shall be closed to traffic for a maximum of 20 Working Day Period. During Highway 427 northbound closure, the Contractor shall complete the removal of existing pavement and resurfacing between Highway 7 and Zenway Blvd. The northbound lanes closure period shall be completed before August 31, 2014.

After the completion of works on Highway 427 northbound lanes, Highway 427 southbound between Zenway Blvd and Highway 427 shall be closed to traffic for a maximum 20 Working Day Period. During closure, the Contractor shall complete the removal of existing pavement and resurfacing between Highway 7 and Zenway Blvd. The southbound lanes closure period shall be completed before September 30, 2014 and will include the Zenway Blvd. W-S ramp to Highway 427.

After hours work will be necessary to layout the traffic staging, mobilization and demobilization, delivery of materials and equipment, temporary concrete barrier relocation, pavement marking painting, pavement removal and paving.

Standard equipment for pavement work shall be used in the work area.


