47            **DESIGNATION OF PUBLIC PARKING AT KLEINBURG UNITED CHURCH**

***Whereas***, the purchase included a large parking lot that has the capacity to hold up to 20 vehicles, and

Marilyn:

As per our discussion last week, City staff inspected the parking lot at the Kleinburg church to determine the feasibility of using this area as a public parking lot.

Staff determined that the parking lot contained some tree branches and debris in it, which will be removed by Parks & Forestry Operations staff.

The Manager of Road Maintenance Services indicated that the parking lot itself is safe, and sees no issues with the proposed use.

It is recommended that appropriate signage be installed to indicate this is a City of Vaughan owned public parking lot, and, lines be painted to maximize the available space for vehicle parking. Consideration should also be given to indicating the maximum allowable time for parked vehicles to remain in the lot.
