  - a. A contingency allowance in the amount of \$75,000.00, plus applicable taxes, be approved within which the Commissioner of Engineering and Public Works or his designate is authorized to approve amendments to the contract;
  - b. A Geotechnical and Material Testing amount of \$10,000.00, plus applicable taxes be approved, to ensure compliance with all applicable standards;
  - c. Additional funding in the amount of \$103,000.00 be transferred from Capital Project EN-1872-13 to cover the shortfall;
- 3. That the inclusion of this matter on a Public Committee or Council agenda with respect to amending the capital budget identified as Award of Tender T13-136 and Budget Amendment is deemed sufficient notice pursuant to Section 2(1)(c) of By-Law 394-2002

A total of 10 sets of bid documents were picked up from the Purchasing Services Department and the following 4 compliant bids were received:

In 2012, a condition assessment was undertaken on the bridge deck to identify the extent of deterioration and determine the most appropriate rehabilitation method. A preliminary budget estimate was developed based this on information. During the design phase, additional investigations were carried out identifying that more extensive rehabilitation of the bridge is required, which has resulted in the tender exceeding the preliminary budget amount.

The engineering estimate for the construction bid of this project was \$470,000.00, excluding H.S.T.

This project is of short duration, however, is considered to be high in complexity. It is difficult to accurately estimate the extent of work required to carry out the rehabilitation of a bridge. Estimates are derived from visual inspections and obtaining samples (coring) of the bridge to accurately try to determine the current structural condition.
