Background – Analysis and Options

The subject plans shown on Attachment #1 are located north of Major Mackenzie Drive, between Huntington Road and Regional Road 27, in Part of Lots 21 and 22, Concession 9, City of Vaughan.

Street names were approved by Vaughan Council on June 26, 2012 for the Nashville Developments Inc. Plan of Subdivision. Prior to Vaughan Council's approval, discussions were ongoing between the applicants, City of Vaughan staff and the Region to determine acceptable names. The street names Agar Street East and Agar Street West were not properly screened and thus duplicated from another approved development. The street name Chesley Crescent is too similar to Chesney Crescent.

The Region of York Transportation and Community Planning Department has no objection to the proposed names. The Vaughan Fire and Rescue Services Department and Vaughan Development Planning Department have also reviewed the proposed street names, which are considered to be satisfactory.

The proposed street names are consistent with the City's Street Naming Policy that was approved by Vaughan Council on June 26, 2012.



LOCATION: Part of Lots 21 - 25, Concession 9


