



Phase one of vivaNext rapidway construction along Highway 7 West is underway in the Vaughan Metropolitan Centre and we're preparing for construction of phase two. Phase two includes building rapidway lanes from the intersection of Centre Street and Highway 7 to Yonge Street, via the existing Viva route on Centre and Bathurst Streets. It also includes rapidway lanes in western Vaughan from Edgeley Boulevard to Helen Street. We're committed to keeping you informed, to work with you and provide up-to-date information with each phase of this project.

Starting this month, crews will be removing the vacant building owned by York Region on Centre Street, just west of New Westminster Drive [see map below]. Removal of the building will allow for a future driveway to be built.

Over the summer, we worked with Habitat for Humanity to salvage all available furniture and building materials from the property. Nearly 80 items were offered as donation to Habitat for Humanity's ReStore, the sale of which will help fund Habitat homebuilding projects.





With the rapidway being built in the centre of the road, motorists will have to cross a wider intersection. To help them do this, we are installing dedicated left-turn traffic signals. Drivers can only turn left when the left-turn arrow is illuminated.

Intersections will now be wider with more lanes and dedicated left-turn traffic signals. As a result, pedestrians may now cross Highway 7 in two stages if unable to get to the other side during the first signal.To help guide them safely across, new signals with a countdown will be installed. The countdown will let pedestrians knowhow many seconds they have left to safely cross the street.



There will also be a waiting area in the middle of the crosswalk, where pedestrians can push the "walk" button and wait for the next light before crossing the second half of the street, if more time is needed to cross.

With these intersection changes, we want to make sure pedestrians and drivers navigate through our community safely. Here are some reminders of how to use the signals properly:


- > It is only safe to start crossing the intersection when the "walk" signal is displayed. Always remember to proceed with caution and watch out for turning vehicles.
- > Do NOT step off a curb when the red hand signal is flashing. However, if the red hand signal shows as you're crossing the road, continue walking to the middle or curb.
- > Don't forget to push the "walk" button at the waiting area. If you don't press the button, the signal will remain timed for cars, not pedestrians.

vehicle access to plazas and entrances

To access mid-block destinations on the opposite side of the road, vehicles can make U-turns at intersections. Motorists will have to drive past their destination to an intersection with a U-turn sign. Once the dedicated left turn traffic signal is illuminated, they can safely make a U-turn and head towards their destination. Global studies

of traffic control have shown this to be a safer way to turn left on a multi-lane road.



EDCO, an agent of York Region Rapid Transit Corporation has written to City of Vaughan By-law & Compliance, Licensing & Permit Services requesting an exemption to the City's Noise By-law for the purposes of construction in connection with the H2-West and H2-East vivaNext BRT Project (Attachment No. 2).

The scope of this phase of the vivaNext BRT Project consists of road resurfacing, sewer crossings, traffic staging (including traffic signal modifications and line painting), safe access/egress and to allow for deliveries for the installation of bus lanes associated with bus transit routes. The after hours construction activities are requested in order to minimize impacts to surrounding businesses, vehicular and pedestrian traffic, limit the need of daytime driveway closures and utility service disruptions.

Construction work activities that will occur outside of the Noise By-law restrictions will include the use of conventional construction equipment such as excavators, backhoes, dozers, triaxle trucks, paving equipment, line painting equipment, utility bucket trucks, etc.

Noise Mitigation

The Applicant will be required to minimize idling of construction vehicles, avoid unnecessary revving of engines, banging of tailgates and use of airbrakes, as well as be required to maintain equipment in good working order (including the use of muffling devices) to minimize noise impacts and to select travel routes to avoid noise sensitive areas where possible.

Relationship to Term of Council Service Excellence Strategy Map (2014-2018)

This noise exemption is directly related to the Term of Council Priority and Service Excellence Strategy Map by:

- 1) Continuing to develop transit options to get around the City;
- 2) Improve municipal road network;
- 3) Invest, renew and manage infrastructure and assets.

Regional Implications

The proposed work is being carried out by York Region Rapid Transit Corporation (vivaNext) and its agents (EDCO).

Conclusion

This request for noise exemption is necessary municipal work in connection with the H2-West and H2-East vivaNext BRT Project. LETTER OF INTENT - NOISE BY LAW EXCEMPTION APPLICATION

The following letter of intent is made in support of the noise by-law exception application made by EDCO Construction, a joint venture between EllisDon and Coco Paving. This application is made in regards to the next phase of the vivaNext bus rapid transit (BRT) project; specifically titled the "vivaNext BRT Project (H2-West and H2-East)". The Owners of the Project are York Region and Metrolinx.

The Project is split into four areas within the City of Vaughan (see attached project map) as follows:

- 1. Highway 7 from Islington Avenue to Edgeley Boulevard (H2 West).
- 2. Centre Street from Highway 7 to Bathurst Street (H2 East)

3. Bathurst Street from Centre Street to Highway 7 / Bathurst Street Connector Ramp (H2 East)

4. Highway 7 from Bathurst Street to Yonge Street Connector Road (H2 East)

note: can the permit please be issued to cover the more exact limits of: Bathurst Street from 100m south of Centre Street to 100m north of the Bathurst Connector Ramp

The work is scheduled to take place over the next 4 years up to 2020. Works are required after hours in order to minimize:

- impacts to vehicular & pedestrian traffic
- impacts to surrounding businesses
- day time closures of driveways
- utility service disruption

Works are also required for constructability reasons including, but not limited to:

- echelon paving
- sewer crossings
- traffic staging (including traffic signal modifications and line painting)
- safe acess / egress
- deliveries

Highway 7 (H2-West) is largely a commercial area, however there is a pocket of residential neighbourhood between Pine Valley and Ansley Grove. These residential areas are covered by a noisewall and thus impacts should be minimized.

Center Street (H2 East) is a mixed use commercial and residential area. The residential area on the south side of Centre Street also has a noisewall. Most residential properties on the north side of Centre Street are abandoned / vacant for future development.

Bathurst Street (H2 East) is a mixed use commercial and residential area. The residential area on the east side of Bathurst Street has a noisewall to mitigate impacts.


Highway 7 (H2 East) is an open laned highway with Highway 407 to the South and a golf course to the north. There is a small section of residences on the north side of Highway 7 near Yonge Street, but there is a noisewall in place in this section to mitigate impacts.

The types of equipment being used will vary, but will generally include conventional construction equipment like excavators, backhoes, dozers, triaxle trucks, paving equipment, line painting equipment, utility bucket trucks etc. EDCO does not anticipate the use of heavy vibration equipment such as drill rigs or pile driving equipment.
