# **Purpose**

The purpose of this report is to seek Council's consideration of applications received in response to the extended recruitment process for citizen appointments from Wards 1, 2 and 4 to the Canada 150 Celebration Task Force.

# Background - Analysis and Options

At its meeting on May 17, 2016, Council adopted Item 26, Report No. 21 of the Committee of the Whole, titled "Appointments to the Canada 150 Celebration Task Force". In so doing, Council approved the appointments of one (1) citizen representative from Ward 1, two (2) citizen representatives from Ward 3 and two (2) citizen representatives from Ward 5.

The terms of reference for the Canada 150 Celebration Task Force require that ten (10) citizen members with at least one person representing each of the City's five wards, be appointed to the Task Force. In view of the shortfall of representation from Wards 1, 2 and 4, Council requested that the City Clerk organize an extended recruitment for citizen representatives from these Wards.

Following Council adoption of these recommendations, the City Clerk's Office co-ordinated an extended recruitment process, which was done through the placement of advertisements in the Vaughan Citizen and Thornhill Liberal, on June 2, 2016. The deadline for receiving applications was 4:30 p.m., Friday, June 17, 2016. In addition, application packages were made available at the Joint Operations Centre (JOC), Community Centres and all branches of Vaughan Public Libraries. Application packages were also available at the City Clerk's Office, City Hall and on the City of Vaughan website. Applications were sought for the following citizen representatives on the Task Force:

- Citizen representatives from Wards 1, 2 and 4.
