10 COMMEMORATIVE PLAQUES DISPLAYED IN FORMER CITY HALL

The City Clerk, in consultation with the Cultural Services Manager, Manager of Facilities, and Interim City Archivist, recommends:

Contribution to Sustainability

The City of Vaughan Archives ensures administrative efficiency, government transparency and public accountability through the management and preservation of the Corporation's records. The plaques previously displayed at Old City Hall sustain the rich history of Vaughan's government and also honour the brave citizens who gave their lives during the two World Wars.

Economic Impact

Depending upon the nature and extent of Council's recommendation in this matter, funds will be required to be allocated to properly display the plaques. Should the plaques be displayed within the Archives, installation costs can likely be absorbed within existing budget.

Communications Plan

This report will be made available on the City's website and in the Committee of the Whole agenda. Should it be determined that the plaques are to be placed on public display, a communication plan will accompany installation.

Purpose

The purpose of this report is to respond to Council's request for an update on plaques previously on public display at Old City Hall.

Background - Analysis and Options

At its meeting on June 23, 2015, Council adopted Item 24, Report No. 24 of the Committee of the Whole entitled 'New Business – Request for a Report on the Plaques Previously Displayed at the Old City Hall', brought to the attention of the Committee by Councillor lafrate. In doing so Council requested that the report include the current location and intent for the plaques.

Fifteen plaques were removed from Old City Hall on June 8, 2012 by Building and Facilities staff and transferred to the City Archives. The Archives' storage space is a climate controlled, secure facility which manages and preserves the City's permanent records.

The modern design and architecture of New City Hall needs to be considered if it is contemplated that the plaques be re-hung. The new City Hall features clean lines and elegant symmetry. Central to the theme of the new building is openness and transparency as represented by its many glass doors and walls. Opaque artwork and plaques have a tendency to overpower their spaces, and so any area created for the plaques should be sympathetic to this modern architecture.

There are several options for displaying the plaques. One possibility is to display the plaques in a rotating exhibit or to only bring them out during special occasions. The extreme weight of each plaque would require special hanging apparatus, and damage to walls would need to be repaired each time the plaques were removed. Another possibility is to display them in a building other than City Hall, such as the Joint Operations Centre, Vellore Hall or other heritage building. The security of the plaques in a heritage building cannot, however, be assured. A third possibility, is to display the plaques in the City Archives as there is a large amount of white wall space available for use, and the medium of the plaques would complement the environment and tone of the Archives' space.

There are no immediate plans to display the plaques. As artifacts of Vaughan's past, however, it is important that they continue to be preserved and that the Archives continues to provide access to the plaques for both City staff and the public.


