Purpose

The purpose of this report is to respond to the initial request from Powerstream staff in support of Powerstream's planned application to the Independent Electricity System Operator (IESO) for a groundmounted solar energy project at the closed Vaughan Landfill Site- Lot 26, Concession 3.

Background - Analysis and Options

At a meeting held on September 3rd, Powerstream representatives requested City of Vaughan staff assistance in applying to the IESO FIT (Feed in Tariff) 4 program to install a groundmount solar generation project at the closed Vaughan Landfill Site- Lot 26, Concession 3. City of Vaughan staff met to discuss the project and issues related to the lease agreement, zoning of the site and classification of the lands were raised. The provincial program guidelines require confirmation of municipal support as part of any application to the FIT program. Powerstream is working on an accelerated schedule in order to meet the IESO program filing date of the September 30th, 2015.

City staff are now analyzing municipal issues in the hopes of reporting staff recommendations to Council on September 16th, 2015.

Staff recommends that Council direct staff to report on Powerstream's Application to IESO FIT 4 Ground Mount Solar Project at Closed Vaughan Landfill Site at the September 16, 2015 meeting of Council.

BACKGROUND:

At the Committee of the Whole meeting on September 9, 2015, Committee of the Whole directed that staff bring a report outlining the City staff response to PowerStream's request to permit a ground mounted solar energy project at the closed Vaughan Landfill.

PowerStream is planning on applying for the Independent Electricity System Operators (IESO) Feed-in-Tariff (FIT) 4 program to proceed with such a project

The IESO administers the FIT program which is designed to encourage and promote greater use of renewable energy sources for electricity generating projects in Ontario. PowerStream is preparing an application to develop a ground mount solar energy project on the former City of Vaughan landfill site. The solar energy project would be a 500kWac utilizing 1875 320watt 72-

memorandum

cell modules and 25 20kWac string inverters and require an approximate area of 200 x 50 metres plus any necessary access roads. The FIT 4 program's application window is commencing on September 30th, 2015 and early application is encouraged.

PowerStream requires that the City of Vaughan's Council support this project and application to the FIT 4 Program through the execution of three documents:

- IESO Prescribed Form: Land Use Exemption Resolution the form will allow PowerStream to construct the ground mounted solar panels on the old Vaughan Landfill as, when executed, PowerStream will be exempt from the FIT 4 rule regarding the ineligibility of building a non-rooftop solar panel facility on property which abuts a nonrural residential property. (Attachment 1)
- IESO Prescribed Form: Municipal Council Support Resolution this form, when executed, will award PowerStream priority points in the FIT 4 application process, which may result in PowerStream being offered a FIT contract prior to others applying for a FIT contract.(Attachment 2)
- 3. IESO Prescribed Form: Municipal Council Confirmation Resolution this form, when executed, confirms support for the program and must include the two forms listed above. (Attachment 3)

The proposed project is proposed to be located on a portion of the land that was the former City of Vaughan landfill site. The property is bordered by an unopened road allowance (projection of Teston Rd) to the south and sits between major streets of Keele Street to the west and Dufferin Street to the east. The subject property is much larger than the actual space needed or required to develop the proposed solar project. As described above only a 200 x 50 metre space is required, excluding access roads. Please see Attachment 4.

City Staff will work with the Ministry of Environment and Climate Change (MOECC) and the Regional Municipality of York to address other considerations

Land Use Restrictions on Closed Landfill

The Vaughan Landfill was closed in 1984. The Ontario Environmental Protection Act (EPA) does not require formal approval for the use of Lands Previously used for Disposal of Waste after a period of twenty-five years has passed from the year in which the land ceased to be used as a waste disposal site. City staff will work with the Ministry of the Environment and Climate Change (MOECC), and PowerStream in order to determine any additional considerations for the proposed solar energy system on the landfill.



The MOECC Guideline D-4 'Land Use On or Near Landfills and Dumps' applies to all proposals for land use on or near a landfill or dump which contains municipal solid waste. There are several factors to consider when land use is proposed on or near a closed landfill including: leachate, odour and litter issues, contaminant discharges from associated vehicular traffic, visual impact, dust, noise, other air emissions, fires, surface runoff, and vectors and vermin. The guideline does suggest that particular attention shall be given to the production and migration of methane gas. In addition, where technical controls for leachate, or leachate and gas are required surrounding a fill area, no land use may take place within 30 metres of its perimeter. The distance may be reduced to 20 metres in cases where only gas controls are necessary.

The closed Vaughan Landfill has a landfill gas collection system which extracts methane gas through wells connected to two vacuum blowers. The extracted landfill gas burns at an enclosed flare. The post-closure care of the landfill incorporates a monitoring program to inspect the operation and effectiveness of the landfill gas control system as well as monthly inspections of the landfill cover.

The proposed solar energy project in the Vaughan Landfill site will be designed to incorporate the characteristics of the landfill cap and other landfill systems (groundwater monitoring, gas collection, etc.) Staff will work closely with the MOECC, the City's landfill consultant and PowerStream to ensure all monitoring and post-closure activities are taken into account during the development of the project.

Planned Teston Road connection

Both the Regional Municipality of York and the City have identified a need to build a Teston Road between Keele Street and Dufferin Street. The Region of York will be developing a Terms of Reference in 2016 for an Individual Environmental Assessment (IEA) to complete the connection. The IEA is set to commence in 2017.

If the project is approved, future siting for the solar panels will be determined in conjunction with PowerStream, York Region and other stakeholders. Impacts to adjacent residents, and impacts on the future Teston Road connection will be considered and resolved.

Provincial Land Use Regulations

PowerStream will adhere to the requirements of the Green Energy Act and the policies of the Oak Ridges Moraine referenced in the Green Energy Act and provincial regulations as part of the project.



Vaughan Official Plan

Section 12.3 (Keele Valley Landfill Area" of the Vaughan Official Plan – 2010) provides as follows:

- The subject site is located on the old Vaughan Landfill site.
- It is designated as "Private Open Space" and "Natural Areas". It is also shown as part of Policy Area 3.
- Policy Area 3 forms part of the buffer area surrounding the Keele Valley Landfill area to the south.
- The primary uses permitted in Area 3 are groundwater, stormwater and landfill gas monitoring and the control and the attenuation of leachate, subject to the provisions of the Environmental Protection Act

The area is subject to MOECC Certificate of Approval A-230610. PowerStream will be required to meet all the requirements of the MOECC in providing for this use.

PowerStream through the FIT application process must submit Council support for the project

Canadian Land Inventory Land Classification considerations

The FIT program restricts the development of ground mount solar projects on prime agriculture lands that are classified as Canadian Land Inventory (CLI) Class 1, 2 or 3 and CLI Organic or Specialty Crop Areas. The subject property has a small portion of CLI class 1-3 in it is south easterly corner, however the majority of the property is CLI 4-7 lands.

The FIT eligibility rules provide an exemption to the CLI classification restrictions for projects to be located on a closed landfill. The Approved Official Plan confirms that the property (PIN) in which the project site is to be developed is within the boundaries of the closed Vaughan Landfill Site.

Considerations regarding adjacent residential properties

The landfill property is eligible under FIT 4 program rules for non-rooftop solar based on land classification because it is located on a closed land fill and exempt from CLI class 1,2 or 3 land restrictions. However, the landfill property is ineligible under FIT 4 program rules for non-rooftop solar since the property abuts a non-rural residential property. The City of Vaughan Council can execute an IESO Prescribed Form: Land Use Restriction Exemption Resolution. The IESO Prescribed Form: Land Use Restriction Exemption Resolution states the following:



Council of the City of Vaughan exempts the Project on the Lands as described above from any or all of the residential, commercial and industrial land-use restrictions as identified in Sections 2.3(e), 2.3(f), 2.3(g) and 2.3(h) of the FIT Rules, Version 4.0.

All considerations listed above and otherwise discovered through the investigation must be resolved in a satisfactory answer

City of Vaughan staff and PowerStream, while consulting with the MOECC may identify additional siting considerations. However, City of Vaughan and PowerStream staff will continue work on the items listed above and any new items which may arise through the course of the application process, to achieve mutually satisfying resolutions.

CONCLUSION:

Staff have performed preliminary reviews of the project and the items which need to be considered. Further investigation and review is expected to result in a positive resolution of these considerations. Therefore, staff are comfortable recommending an endorsement of this project.

Supporting ground mounted renewable energy projects is consistent with the priorities previously set out by Council in Green Directions Vaughan, the Community Sustainability and Environmental Plan.

Staff will continue to work with PowerStream and the MOECC throughout the FIT 4 process.

Purpose

The purpose of this report is to respond to the initial request from Powerstream staff in support of Powerstream's planned application to the Independent Electricity System Operator (IESO) for a groundmounted solar energy project at the closed Vaughan Landfill Site- Lot 26, Concession 3.

Background - Analysis and Options

At a meeting held on September 3rd, Powerstream representatives requested City of Vaughan staff assistance in applying to the IESO FIT (Feed in Tariff) 4 program to install a groundmount solar generation project at the closed Vaughan Landfill Site- Lot 26, Concession 3. City of Vaughan staff met to discuss the project and issues related to the lease agreement, zoning of the site and classification of the lands were raised. The provincial program guidelines require confirmation of municipal support as part of any application to the FIT program. Powerstream is working on an accelerated schedule in order to meet the IESO program filing date of the September 30th, 2015.

City staff are now analyzing municipal issues in the hopes of reporting staff recommendations to Council on September 16th, 2015.

Staff recommends that Council direct staff to report on Powerstream's Application to IESO FIT 4 Ground Mount Solar Project at Closed Vaughan Landfill Site at the September 16, 2015 meeting of Council.
