8 AWARD AMENDMENT FOR QUOTATION Q15-224 FOR SIDEWALK ON ISLINGTON AVENUE FROM CAPNER COURT TO BINDERTWINE BOULEVARD WARD 1

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Commissioner of Public Works and the Director of Capital Delivery and Asset Management, dated September 9, 2015:

Recommendation

The Commissioner of Public Works and the Director of Capital Delivery and Asset Management, in consultation with the Director of Purchasing and Director of Financial Planning & Analytics, recommend:

- 1. That the contract amount for Quotation Q15-224 for sidewalk on Islington Avenue from Capner Court to Bindertwine Boulevard be increased by \$17,000, to a total value of \$85,143.90, plus applicable taxes, to address the increases in construction costs; and
- 2. That the award increase plus applicable taxes and administration recovery be funded from funds available in approved Capital Project EN-1961-13 Sidewalk on Islington Avenue missing links from Major Mackenzie Drive to Westridge Drive.

Contribution to Sustainability

The sidewalk installation on Islington Road from Capner Court to Bindertwine Boulevard will ensure that an acceptable level of service by the City's infrastructure is maintained for the health and wellbeing of its citizens.

The sidewalk installation will help promote walking as means of transportation. This is consistent with Green Directions Vaughan Goal #3: To ensure that Vaughan is a City that is easy to get around with low environment impact, in particular, Objective 3.1: To develop and sustain a network of sidewalks, paths and trails that supports all modes of non-vehicular transportation.

Economic Impact

On April 24, 2015, the Director of Purchasing Services, in accordance with the Consolidated Purchasing Policy, awarded Quotation Q15-224 for the construction of sidewalk on Islington Avenue from Capner Court to Bindertwine Boulevard to Aqua Tech Solutions Inc. The total value of the assignment, excluding H.S.T., was \$61,943.90, with a contingency allowance of \$6,200.00.

Additional costs incurred during construction to address the unfavorable site conditions primarily resulting from additional excavation have resulted in additional work in the amount of \$23,200. After utilizing the approved contingency allowance of \$6,200, an additional award amendment of \$17,000 is required. As a result, the total value of the assignment will be increased to \$85,143.90, including contingency allowance, plus applicable taxes.

Sufficient funds for the additional works are available within Capital Project EN-1961-13 Sidewalk on Islington Avenue - missing links from Major Mackenzie Drive to Westridge Drive.

Aqua Tech Solutions Inc. was awarded Quotation Q15-224 to undertake the construction of the sidewalk on Islington Avenue

The construction of the sidewalk on Islington Avenue from Capner Court to Bindertwine Boulevard was originally scheduled for Summer 2015. However, based on feedback received from the Kleinburg community, the time allocated for both design and construction activities were compressed to have the sidewalk completed prior to the June 4, 2015 community event, known as Jane's Walk. Capital Delivery and Asset Management staff worked in collaboration with the City's Urban Design Division as well as the Trees for Kleinburg community advocacy group, to undertake the detailed design for this project.

To ensure that the agreed upon timelines could be met, Quotation Q15-224 was awarded to Aqua Tech Solutions Inc. on April 24, 2015, and the work was substantially completed on June 1, 2015.

Additional costs were incurred as a result of an early completion date for this project

As previously indicated, overall project delivery timelines were compressed to ensure that the sidewalk construction and the associated tree plantings were completed before the June 4, 2015 community event. To meet the delivery timelines, the design activity and the tendering process were fast tracked during the winter and early spring seasons. As a result, weather conditions were not conducive to accurately capturing the field conditions and which in turn did not fully inform the detailed design review prior to tendering. Increases in excavation quantities were experienced during construction, resulting in the additional expenditures.

To minimize these additional costs and ensure that the work was completed in advance of June 4, 2014 deadline, City staff directed the contractor to proceed with the required work.


