Background - Analysis and Options

The 2018 Schedule of Meetings is structured on a monthly three-week cycle and takes into consideration statutory holidays, significant faith days and Regional Council and Committee meetings. The schedule has been prepared in accordance with Procedure By-law 7-2011 and the adopted Standing Committee Structure.

Every effort has been made to avoid scheduling meetings of Council on significant faith and cultural days that Council and staff are made aware of. The FCM Conference scheduled June 1 – 3, 2018, the AMCTO Conference scheduled for June 11 – 13, 2018, and the AMO Conference scheduled for August 19 – 22, 2018 have also been considered in preparing the schedule.

In keeping with the practice of the past two years, unless necessary, the schedule has been structured to avoid the negative aspects of stacking three committee meetings on one day and avoids scheduling meetings on the last full week of the month.

Should a Committee or Council meeting be required to deal with any pressing issues that may arise, a Special Committee or Special Council meeting may be summoned by giving 24 hours' notice in accordance with the Procedural By-law.

Nomination Day is July 27, 2018, and one full cycle has been scheduled commencing September 4, 2018, after this date.

A Special Council (Closed Session) – Education Session has been scheduled for December 14, 2018.

Deviations to the Schedule

Deviations have been made to the structure of the schedule to accommodate statutory holidays and significant faith days.

Some of the significant changes are noted below.

January 2018	Due to the Holidays, the meeting cycle begins on the last full week of the month.
March 2018	Committee of the Whole (Working Session) has been scheduled on Wednesday instead of the following Monday due to Spring Break.
June 2018	Due to the FCM and AMCTO Conferences, it was necessary to stack 3 meetings on Tuesday, June 5 th and schedule the Finance, Administration and Audit Committee and the Committee of the Whole (Working Session) meetings on Wednesday of the same week instead of the following Monday.
September 2018	One cycle of meetings is scheduled for the first week of September after Nomination Day on July 27 and before Election Day on October 22.
December 2018	The Inaugural Council meeting is scheduled for December 4 and a full cycle of meetings is scheduled to commence on December 5, 2018.
