The Interim Commissioner of Legal & Administrative Services/City Solicitor and the Director of By-law & Compliance recommend:

- 1) That the D.M. Wills Associates Limited, on behalf of the Ministry of Transportation be granted a noise exemption, in accordance with the City's Noise By-law #96-2006, for the purposes of pavement rehabilitation on Highway 400 between Steeles Avenue and just north of Highway 7 for the period of January 2, 2016 through January 31, 2017.
- 2) That this request for noise exemption be granted with the following conditions:
 - a) That notice of the impending work be provided to surrounding residents and business owners within a minimum 60 metre radius;
 - b) That public notification of the proposed work be placed in Vaughan local newspapers;
 - c) That the notice to residents and business owners include contact information for D.M. Wills Associates Limited and/or contractors conducting the work;
 - d) That no construction take place on Sundays or statutory holidays; and
 - e) That noise mitigation measures be implemented by ensuring that:
 - unnecessary noise related to equipment be minimized where possible;
 - there be no unnecessary idling of vehicles; and

The initiatives outlined in the request for Noise Exemption for the purposes of pavement rehabilitation on Highway 400 contribute to the City's Community Sustainability Plan by supporting transportation infrastructure.

Background - Analysis and Options

The City of Vaughan Noise By-law #96-2006 prohibits noise created from the use of "construction equipment" as defined, between the hours of 7:00pm of one day to 7:00am the following day and on Sundays or statutory holidays.

Any noise created by construction activity during these prescribed hours requires an exemption to the provisions of the By-law. Exemption requests for construction noise are governed by the provisions of Section 19, Exemption – Construction.

The Applicant submitted a written request to the City of Vaughan By-law & Compliance Department requesting an exemption to the Noise By-law for the purposes of pavement rehabilitation on Highway 400.

The specific location and activities of the construction include:

- Pavement rehabilitation on Highway 400 northbound from Steeles Avenue West to Regional Road 7;
- Pavement rehabilitation on Highway 400 southbound from north of Steeles Avenue West south of Vaughan's border;
- Pavement rehabilitation on miscellaneous ramps and portions of Steeles Avenue West within the Ministry's right-of-way;
- Traffic signal improvements;
- Replacement of affected vehicle detection and counting loops.

The construction activities will include, but are not limited to, the use of the following equipment:

- Tandem and triaxle trucks;
- Asphalt pavers;
- Milling machines;
- Rubber tire rollers;
- Steel rollers;
- Excavators; and
- Other heavy equipment as required

As described within the Application documents, construction activity is required during prohibited evening hours to minimize traffic disruption and public inconvenience.

The Applicant will ensure that standard noise mitigation measures will be specified in the tender contract package, such as: the contractor will be required to keep idling of construction equipment to a minimum and maintain equipment in good working condition in order to reduce noise from construction activities.

Regional Implications

The work proposed to be carried out is required as necessary municipal work, and will be carried on as part of a tendered contract overseen by D.M. Wills Associates Limited, The Ministry of Transportation's consultant.

Conclusion

This request for a noise exemption pursuant to the City of Vaughan Noise By-law #96-2006 exceeds the delegated authority of the Director of By-law & Compliance. Therefore, Council authorization for the exemption to the By-law is required to permit the Applicant to proceed with the required work as planned.

Staff believes that the road rehabilitation project is necessary municipal work and the request received for a noise exemption should be endorsed by Council pursuant to the recommendations set out in this Report.


