1. That the scope in approved capital project FR-3580-13 Acquire an Air Supply Unit be amended from the refurbishment of Rescue Truck #7966 into an air supply vehicle to the purchase of a new air supply vehicle.

## Purpose

To seek approval to amend the scope of capital project FR-3580-13 from the refurbishment of spare rescue truck #7966 into an air supply vehicle to the purchase of a new air supply vehicle.

#### **Background – Analysis and Options**

Capital project FR-3580-13 Acquire an Air Supply Unit was approved for the addition of an air supply vehicle to transport compressed air breathing cylinders and a compressor to incident scenes to support firefighters working in toxic environments. It was originally recommended that spare rescue truck #7966 be refurbished and repurposed for this use.

Upon further inspection and analysis by Vaughan Fire and Rescue Service, it was determined that the refurbishment of the rescue truck was no longer a viable option given its age and condition. Spare rescue truck #7966 is 15 years old and nearing the end of its useful life. The truck will be disposed of at auction when it is no longer serviceable to VFRS.

The purchase of a new light duty truck was identified as a more suitable alternative for the air supply unit. Since the original scope of the project specified the refurbishment of a spare rescue truck into an air supply vehicle, a scope amendment is required to reflect the purchase of a new vehicle. The scope change does result in a change to the estimated cost of the project.
