Recommendation

The City Clerk recommends:

- THAT the Council of the Corporation of the City of Vaughan support the request of Lake Wilcox Brewing Co. Ltd., and endorse their application to obtain "By the Glass" Manufacturer's Limited Liquor Sales Licences to sell and serve their beer to patrons for consumption in single servings at their manufacturing site;
- 2. THAT authority to issue letters of support for future requests of Vaughan-based companies for "By the Glass" Manufacturer's Limited Liquor Sales Licences to sell and serve their products to patrons for consumption in single servings at their manufacturing site, be delegated to the City Clerk;
- THAT prior to the letter of support being issued, all such requests be circulated to City of Vaughan Fire and Rescue Services, City of Vaughan By-Law & Compliance, Licensing and Permit Services, the Chief Building Official for the City of Vaughan and Members of Council for comment; and
- 4. THAT the fees & charges by-law be amended to allow a charge of \$41.00 for the issuance of the letter of support.

The delegated authority provided by the adoption of the recommendations in this report serves as blanket authority, and provides a mechanism for the appropriate review to take place.

Dear Janice,

Currently Lake Wilcox Brewing Co. (LWB) is under construction at 1033 Edgeley Blvd Unit 3 Vaughan, Ontario (building permit #16-847). Lake Wilcox Brewing Co. will be operating a full production brewery with the intent of selling to our existing The Beer Store, LCBO, licensee and future retail customers. In addition to these account LWB is requesting a letter of support and resolution from the City of Vaughan acknowledging the application for a limited liquor license to the AGCO. The purpose of this license was creating in partnership with the AGCO and Ontario brewers to promote craft beer education and tourism. See below.

Manufacturer's Limited Liquor Sales Licence ("By the Glass")

Wineries and breweries may make an application to the AGCO for a Manufacturer's Limited Liquor Sales Licence ("By the Glass") to sell and serve their products for conveyance and consumption on their manufacturing site(s) where the sale is primarily aimed at promoting the manufacturer's product and either providing an enhanced tourist experience or fulfilling an educational purpose.

Only Ontario wineries and breweries which hold a Manufacturer's Licence (issued pursuant to the Liquor Licence Act) are eligible for this licence.

This allows Ontario wineries and breweries to sell and serve wine or beer which it has manufactured in servings whose quantities do not exceed 341 ml (12 oz) for beer and 142 ml (5 oz) for Ontario wine. Beer or wine may only be sold between 11:00 a.m. and 9 p.m. on any day. These hours may not be extended and no liquor sales licence endorsements are available for this type of sales licence.

Guests are allowed to carry and consume wine and beer on the manufacturing site in areas that are under the sole control of the manufacturer and approved under the licence. Wine and beer will not be permitted in such areas as public roads, thoroughfares, driveways and parking lots, or in other areas that may raise public safety concerns.

The Taproom in the retail area of our Brewery is approx. 1770 square feet with a zoned occupancy of 41 people including staff. The facility is equipped with 2 customer use washrooms complete with universal access. We will be selling both 5oz and 12oz tastings as per AGCO regulations. LWB is not required by the AGCO to provide food in addition to the sale of these tasting size portions due to the smaller serving sizes being sold per person. That being said it is the responsibility of LWB and its trained service staff to regulate the volume and ensure public safety.

The goal of the "By the Glass" license is to enhance the brewery experience for our customers and educate them on the brewing process and how we combine unique malts and hops to create award winning craft beers. We look forward to working in the City of Vaughan and attracting out of town customers and servicing local customers.
