DECOMMISSIONING OF VOLUNTEER FIRE STATION 7-4 WARD 1

Contribution to Sustainability

VFRS is the seventh largest career fire department in the province, with a full-time complement of more than 266 career firefighters, and it also continues to have volunteer firefighters. The City's counter parts, such as Richmond Hill, Markham, Central York, and others, have long since ceased to use volunteers.

Economic Impact

Budget funding associated with operating the building will still be required. There will be nominal savings redeployed to cover additional 2014 fire training costs.

The 10665 Islington Avenue volunteer-based Fire Station 7-4 has been experiencing a decline in the number of available volunteer firefighters. VFRS has noted that there has also been some difficulty in attracting prospective volunteers due to the change of demographics in the community. Today, the City's volunteers consist of Community College graduates seeking to build their resumes while seeking full-time employment. For example, VFRS Station 7-4 had 18 volunteers in early 2013 and currently there are 10, as 8 of those volunteers have successfully been recruited by other fire departments (three volunteers were hired by VFRS).

The volunteers are led by a Captain who has been in the service for more than 40 years and has expressed the desire to retire by the end of this year. There is currently no volunteer member eligible to fill this vacancy. The existing station is too small to house the existing fleet of trucks as well as newer models.
