  - c) That the Applicant take measures to minimize idling of construction vehicles, avoid unnecessary revving of engines, use of airbrakes, banging of tailgates and to maintain equipment in good working order (including muffling devices) to minimize noise impacts.
  - d) That no construction take place on Sundays or Statutory Holidays.








### dedicated left-turn traffic signal

With the rapidway being built in the centre of the road, motorists will have to cross a wider intersection. To help them do this, we are installing dedicated left-turn traffic signals. Drivers can only turn left when the left-turn arrow is illuminated.

### two stage pedestrian crossing


Intersections will now be wider with more lanes and dedicated left-turn traffic signals. As a result, pedestrians may now cross Highway 7 in two stages if unable to get to the other side during the first signal. To help guide them safely across, new signals with a countdown will be installed. The countdown will let pedestrians knowhow many seconds they have left to safely cross the street.



There will also be a waiting area in the middle c crosswalk, where pedestrians can push the "wa and wait for the next light before crossing the so of the street, if more time is needed to cross.

With these intersection changes, we want to me pedestrians and drivers navigate through our consafely. Here are some reminders of how to use 1 properly:

- > It is only safe to start crossing the intersection "walk" signal is displayed. Always remember with caution and watch out for turning vehicle
- > Do NOT step off a curb when the red hand sig flashing. However, if the red hand signal show crossing the road, continue walking to the mic
- > Don't forget to push the "walk" button at the v If you don't press the button, the signal will re for cars, not pedestrians.

### demolition at 1082 Centre Street

Phase one of vivaNext rapidway construction along Highway 7 West is underway in the Vaughan Metropolitan Centre and we're preparing for construction of phase two. Phase two includes building rapidway lanes from the intersection of Centre Street and Highway 7 to Yonge Street, via the existing Viva route on Centre and Bathurst Streets. It also includes rapidway lanes in western Vaughan from Edgeley Boulevard to Helen Street. We're committed to keeping you informed, to work with you and provide up-to-date information with each phase of this project.

Starting this month, crews will be removing the vacant building owned by York Region on Centre Street, just west of New Westminster Drive [see map below]. Removal of the building will allow for a future driveway to be built.

Over the summer, we worked with Habitat for Humanity to salvage all available furniture and building materials from the property. Nearly 80 items were offered as donation to Habitat for Humanity's ReStore, the sale of which will help fund Habitat homebuilding projects.



Dear Ms. Heron:

Kiewit-Ellisdon, a partnership (KED) is working along Hwy 7 from Hwy 400 east to 100m east of Bowes Rd. on the vivaNext Project – H2-VMC. The H2-VMC project primarily consists or road widening to allow for the installation of dedicated bus lanes associated with the viva Rapid Transit routes. The work also includes:

- Grading and paving.
- Fencing and barriers.
- Sidewalk and station platform completion.
- Hard and soft landscaping.
- Completion of CN McMillian Bridge.

Noise generating activities also include:

- Removals and demolition Use of excavators, breakers, milling machines, etc.
- Excavating and grading Use of dozers, excavators, trucks, etc.
- Paving and sub-base construction Use of dozers, excavators, rollers, and compactors.

KED will employ all practical and reasonable measures to minimize the level of noise from construction activities. Noise is best reduced at the source, therefore proper selection, operation, and maintenance of equipment will have the greatest effect on the mitigation of noise impacts. Scheduling and planning of activities with noise at certain times and intervals can also reduce the likelihood of potential impacts or complaints.

Additional Best Management Practices Include:

- Focus on maintenance on lubrication and replacement of worn parts and correction of deficient exhaust systems.
- When practical, shut down heavy equipment that is not active to avoid idling.
  Avoid unnecessary revving of engines and use of airbrakes.
- Avoid banging of tailgates and loader buckets.
- Select travel routes to avoid noise sensitive areas.

After hours construction activities include:

Paving and sub-base construction.

- · Electrical works.
- Drainage and utility works.

KED would like to formally request permission to receive exemption to the Vaughan Noise By-Law #96-2006 until December 31st 2016. If Noise By-Law exemption is granted KED wishes to work 24hours Monday through Saturday to accelerate construction and improve scheduling and associated implications.
