24 RESOLUTION REQUESTED BY A LOCAL WINERY / BREWERY TO SUPPORT AND ENDORSE "BY THE GLASS" MANUFACTURER'S LIMITED LIQUOR SALES LICENCE

Recommendation

The City Clerk recommends:

1. That the Council of the Corporation of the City of Vaughan support the request of Magnotta Winery Corporation and endorse their application to obtain "By the Glass" Manufacturer's Limited Liquor Sales Licences to sell and serve their wine and beer to patrons for consumption in single servings at their manufacturing site.

Purpose

A new regulation enacted under the Liquor Licence Act creates a new category of liquor licence that allows Ontario wineries and breweries to sell and serve their wine and beer to patrons in single servings at their manaufacturing site. Manufacturers wishing to obtain Manufacturer's Limited Liquor Sales Licence "By the Glass" licences must include with their applications to the Alcohol and Gaming Commission of Ontario (AGCO), a resolution approved by the local municipal Council supporting the issuance of such a licence.

This request is before Council as the City of Vaughan has received correspondence (attached) from a local winery / brewery seeking such a resolution for the purposes of applying to the (AGCO) for a "By the Glass" licence.

Background - Analysis and Options

On May 7, 2007, a new Regulation (Ontario Regulation 196/07) was enacted under the provisions of the Liquor Licence Act establishing a new class of liquor licence: a "Manufacturer's Limited Liquor Sales Licence". This new type of licence allows Ontario wineries and breweries to sell and serve the wine and beer which they have manufactured on site, in servings whose quantities do not exceed 341 ml (12oz) for beer and 142 ml (5oz) for wine, between the hours of 11:00 am and 9:00 pm on any day.

INFORMATION BULLETIN - No.19

'By the Glass'
Manufacturer's Limited Liquor Sales Licences
Sale and Service Hours Extended to 9 p.m.
(August 2008)

Effective August 13, 2008, the sale and service hours associated with a Manufacturer's Limited Liquor Sales Licence (i.e. 'By the Glass' licence) were extended to 9 p.m. from the previous cut-off time of 6 p.m. This change was introduced after consulting with stakeholders to further enhance the ability of Ontario wineries and breweries to provide a first-rate tourist experience to their customers.

A Manufacturer's Limited Liquor Sales Licence allows Ontario wineries and breweries to sell and serve their wine and beer to patrons for consumption in single servings at their manufacturing site. The servings must be in quantities that do not exceed 341 ml (12 oz.) for beer and 142 ml (5 oz.) for Ontario wine. The hours of sale and service under this licence are now between 11 a.m. and 9 p.m. on any day.

Manufacturers who already hold a Manufacturer's Limited Liquor Sales Licence are automatically eligible to sell and serve their wine and beer to 9 p.m.

For manufacturers interested in obtaining such a licence, they must first submit an Application for a Manufacturer's Limited Sales Licence (Form #1222) to the Alcohol and Gaming Commission of Ontario (AGCO), along with the appropriate fee, a site plan of the manufacturing site and written confirmation from the council of the municipality within which the applicant's manufacturing site is situated that a municipal resolution has been passed in support of the licence. The proposed licensed areas must be outlined in a clearly defined manner on the site plan.

The application needs to be fully approved by the AGCO before a licensee may permit the sale and service of wine or beer for consumption by patrons at the manufacturing site.
