In honour of IDPD, Mr. Warren Rupnarain, City of Vaughan Accessibility and Diversity Coordinator and members of the Vaughan Accessibility Advisory Committee (VAAC) will represent the City at the third annual December 3 tribute event. The goal of the event is to raise awareness of the International Day of Persons with Disabilities, recognize the contributions of persons with disabilities as well as the challenges that they face.

The event features an award ceremony with awards in various accessibility categories. Mr. Rupnarain was the recipient of “Outstanding Accessibility Champion in York Region” award in 2013. Mr. Rupnarain was asked by the event organizers to present the aforementioned award at this year’s event.

Also, Ms. Meenu Sikand, Chair of the VAAC will present the “Outstanding Accessibility Champion in the Region of Peel” award at this year’s event.

The barriers persons with disabilities face are more prevalent as a result of the environment in which they live in, rather than their impairment.
