4 ASSUMPTION – BRALAWN SUBDIVISION (SOUTH) PLAN OF SUBDIVISION 65M-4139 (19T-97V21) WARD 3 - VICINITY OF PINE VALLEY DRIVE AND MAJOR MACKENZIE DRIVE

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Commissioner of Public Works and the Director of Development/Transportation Engineering, dated December 2, 2014:

Recommendation

The Commissioner of Public Works and the Director of Development/Transportation Engineering recommend:

1. That Council enact the necessary by-law assuming the municipal services that are set out in the Subdivision Agreement for Plan 65M-4139, and that the Municipal Services Letter of Credit be released.

Contribution to Sustainability

The municipal services recommended for assumption in this report have been designed and constructed in accordance with City standards which include consideration for sustainability.

Economic Impact

Upon assumption of this subdivision, approximately 1.4 lane kilometers of roadway and associated municipal services including sanitary sewers, watermain, street lighting, streetscaping, sidewalk, etc., will be added to the City's network of infrastructure. This additional infrastructure is valued at \$ 1,209,764 and will incur the normal expense associated with annual operation and maintenance activities of approximately \$26,725 as shown on the following chart:

The Bralawn Subdivision (South), Plan of Subdivision 65M-4139 is a 45 lot residential development that includes a school block, a park block and a woodlot. It is located in the southeast quadrant of Major Mackenzie Drive and Pine Valley Drive in Ward 3 as shown on Attachment No.1.

The Subdivision Agreement with Bralawn Developments Inc. was executed on May 8, 2009 and the Plan of Subdivision was subsequently registered on August 14, 2009. The construction of the roads and municipal services in Plan 65M-4139 were considered substantially completed on October 3, 2012.

The Developer has maintained the municipal services in the subdivision during the required minimum thirteen month maintenance period and has rectified all noted deficiencies.

The grading of all lots in the subdivision has been certified by the Developer's Engineering Consultant.

Clearances have been received from all pertinent City Departments including Development/Transportation Engineering, Development Planning, Building Standards, Parks Development, Parks Operations and Forestry, Public Works, and Clerks.

In addition, the Development Finance and Investments Department has confirmed that all of the City's financial requirements associated with this subdivision have been satisfied.

Accordingly, the Developer has requested that the roads and municipal services in the subdivision be assumed by the City, and that the development securities held by the City be released.

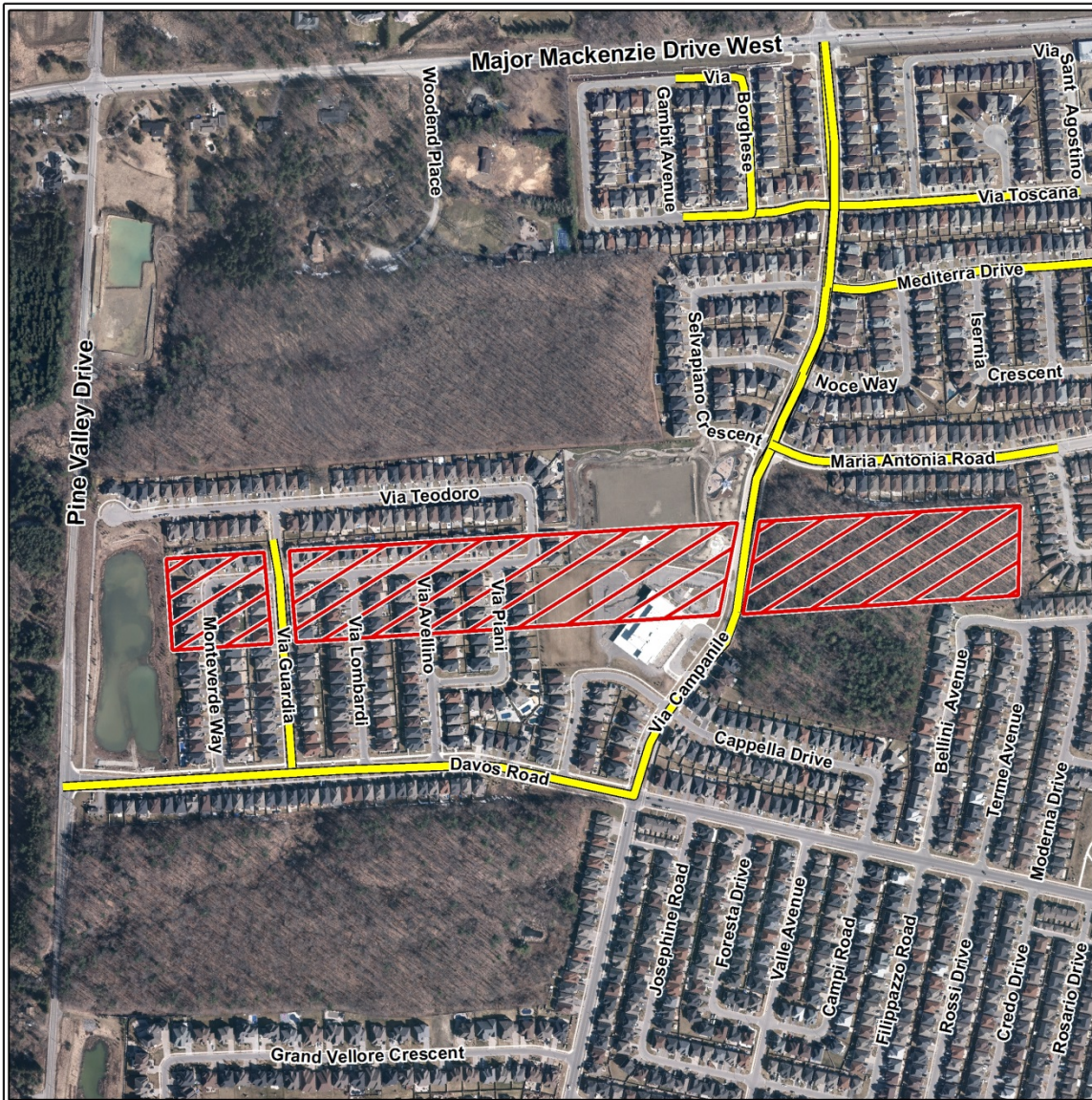

BY-LAW NUMBER 156-2014

A By-law to assume Municipal Services in Bralawn Subdivision (South), 19T-97V21, Registered Plan 65M-4139.

WHEREAS the Subdivision Agreement between the City of Vaughan and Bralawn Developments Inc. provides for the installation of certain public services.

AND WHEREAS the Commissioner of Public Works has received certification that the services in Registered Plan 65M-4139, have been constructed and installed in accordance with City specifications.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- I. THAT the services in Registered Plan 65M-4139, more particularly described in the Subdivision Agreement between The Corporation of the City of Vaughan and Bralawn Developments Inc. dated May 8, 2009, be and they are hereby assumed as public services.
