6 ASSUMPTION –SUGARBERRY SUBDIVISION PLAN OF SUBDIVISION 65M-4137 (19T-97V19) WARD 3 - VICINITY OF PINE VALLEY DRIVE AND MAJOR MACKENZIE DRIVE

The Committee of the Whole recommends approval of the recommendation contained in the following report of the Commissioner of Public Works and the Director of Development/Transportation Engineering, dated December 2, 2014:

Recommendation

The Commissioner of Public Works and the Director of Development/Transportation Engineering recommend:

1. That Council enact the necessary by-law assuming the municipal services that are set out in the Subdivision Agreement for Plan 65M-4137, and that the Municipal Services Letter of Credit be released.

Contribution to Sustainability

The municipal services recommended for assumption in this report have been designed and constructed in accordance with City standards which include consideration for sustainability.

Economic Impact

Upon assumption of this subdivision, approximately 2.5 lane kilometers of roadway and associated municipal services including sanitary sewers, watermain, street lighting, streetscaping, sidewalk, etc., will be added to the City's network of infrastructure. This additional infrastructure is valued at \$ 2,707,592 and will incur the normal expense associated with annual operation and maintenance activities of approximately \$57,378 as shown on the following chart:

The Sugarberry Subdivision, Plan of Subdivision 65M-4137, is a 255 lot residential development that includes woodlot blocks, an open space block and a school block. 

BY-LAW NUMBER 158-2014

A By-law to assume Municipal Services in Sugarberry Subdivision, 19T-97V19, Registered Plan 65M-4137.

WHEREAS the Subdivision Agreement between the City of Vaughan and Sugarberry Holdings Inc. provides for the installation of certain public services.

AND WHEREAS the Commissioner of Public Works has received certification that the services in Registered Plan 65M-4137, have been constructed and installed in accordance with City specifications.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- I. THAT the services in Registered Plan 65M-4137, more particularly described in the Subdivision Agreement between The Corporation of the City of Vaughan and Sugarberry Holdings Inc. dated March 17, 2009, be and they are hereby assumed as public services.
