(VanMar), under contract to the Regional Municipality of York, be granted a noise exemption, in accordance with the City's Noise Control By-law 96-2006, as amended, for the purposes of concrete pouring construction work for development of a new Affordable Housing apartment building at 275 Woodbridge Ave. (north of Kipling Avenue and Highway 7), for the period of December 18, 2017 through to March 31, 2018; and
- 2. That this request for extension be granted with the following conditions for VanMar (the Applicant):
  - a) That construction communication notices be sent to surrounding residents and business owners within a 60-metre radius, in keeping with City standards, advising them of the impending work;
  - b) That the construction communication notices to residents and business owners include contact information for VanMar;
  - c) That the Applicant monitor and investigate any complaints regarding construction noise;
  - d) That the Applicant take all reasonable measures to complete concrete pouring between the hours of 7:00 am and 7:00 pm;
  - e) That the Applicant take measures to minimize any unnecessary noise, including but not limited to idling of construction vehicles, unnecessary revving of engines, use of airbrakes, and to maintain equipment in good working order (including muffling devices) to minimize noise impacts; and
  - f) That no construction takes place on Sundays and Statutory Holidays.


# DETAILED DESCRIPTION OF SOURCE OF SOUND:

Up to four power trowels finishing concrete slab surfaces

# **REASON WHY THE EXEMPTION SHOULD BE GRANTED:**

This is necessary construction work. Concrete requires troweling for a period of time in order for it to properly cure. This requires the concrete finishers to periodically work after 7pm to finish the surface properly. It is difficult to determine how often this will occur. Our goal is always to finish before 7pm.

# **Placing and Finishing Concrete Procedures:**

Mixing, transporting, and handling of concrete should be carefully coordinated with placing and finishing operations. Concrete should not be deposited more rapidly than it can be spread, struck off, consolidated, bullfloated, and deposited continuously as near as possible to its final position.

In slab construction, placing should be started along the perimeter at one end of the work with each batch placed against previously dispatched concrete. Do not dump the concrete in separate piles and then level and work them together; nor should it be deposited in large piles and moved horizontally into final position.

Concrete that will be visible, such as driveways, highways, or patios often need finishing. Slabs can be finished in many ways depending on the intended service used. Where a smooth, hard, dense surface is desired, floating should be followed by steel troweling. Power trowels are used to smooth, and finish poured concrete before it is fully

dry, so timing is a critical element in how the finished product will turn out. Air temperature, humidity, and wind can all affect how quickly or slowly the concrete will dry. Hot windy weather leads to rapid evaporation and thus particular care must be taken to keep the concrete moist. Cold weather causes the concrete to harden much more slowly than hot weather. This delays the construction process, but leads to better concrete overall, because the hydration products develop differently at different temperatures.

Standard practice is to use both a float pan and a finishing blade to smooth the concrete slab. The float pan is attached to the power trowel first, and when the concrete is ready, the power trowel is pushed slowly in front of the worker from one end of the slab to the other, over to the side slightly, and then back in a new row, keeping this line by line pattern until the slab has been power floated over the entire surface. Each successive pass helps to compact the aggregate material in the concrete surface and helps make the pour nice and flat.
