municipality. Delegations are made on matters of a provincial nature that directly affect local municipalities such as municipal finance, urban planning, housing, infrastructure and transportation. The deadline to submit a municipal delegation requests is Friday, January 18, 2013.

Staff has considered City of Vaughan issues which may benefit from such a delegation. Transportation issues have been the subject of such Vaughan delegations in the past.

Within the City of Vaughan, the last several months have seen significant progress on establishing the preferred configuration of the Highway 400/Highway 7 Interchange in the VMC. Also, the proposed Yonge North Subway Extension to the Richmond Hill/Langstaff Gateway Urban Growth Centre has now been included in the next wave of The Big Move projects.

One Vaughan key priority initiative which may benefit from such a delegation opportunity is the issue of a provincial commitment to the construction of the Hwy 427 through the Vaughan Enterprise Zone.

The Vaughan Enterprise Zone comprises more than 2,400 acres of industrial/commercial lands and is projected to accommodate employment for over 60,000 people. The Vaughan Enterprise Zone is already the home to many leading edge companies in advanced manufacturing, plastics, automotive parts, and the food and beverage sector. Support industries, such as transportation (CP Intermodal) and distribution, have capitalized on Vaughan's strategic location. It is well recognized that industrial areas are highly reliant on road capacity so the timely extension of Highway 427 to Major Mackenzie Drive is critical to continued growth in the Vaughan Enterprise Zone.

Accordingly, staff intends to submit a municipal delegation request to the Honourable Bob Chiarelli, Ontario's Minister of Transportation, Infrastructure and Municipal Affairs and Housing to discuss the economic and transportation criticality of the construction of Highway 427 to Major Mackenzie Drive to Vaughan, York Region and the GTA.

Relationship to Vaughan Vision 2020

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Regional Implications

The planning for the extension of Highway 427 has been integrated into all Regional planning to date. A commitment to the extension of Highway 427 will be a significant benefit to the Region.

Conclusion
