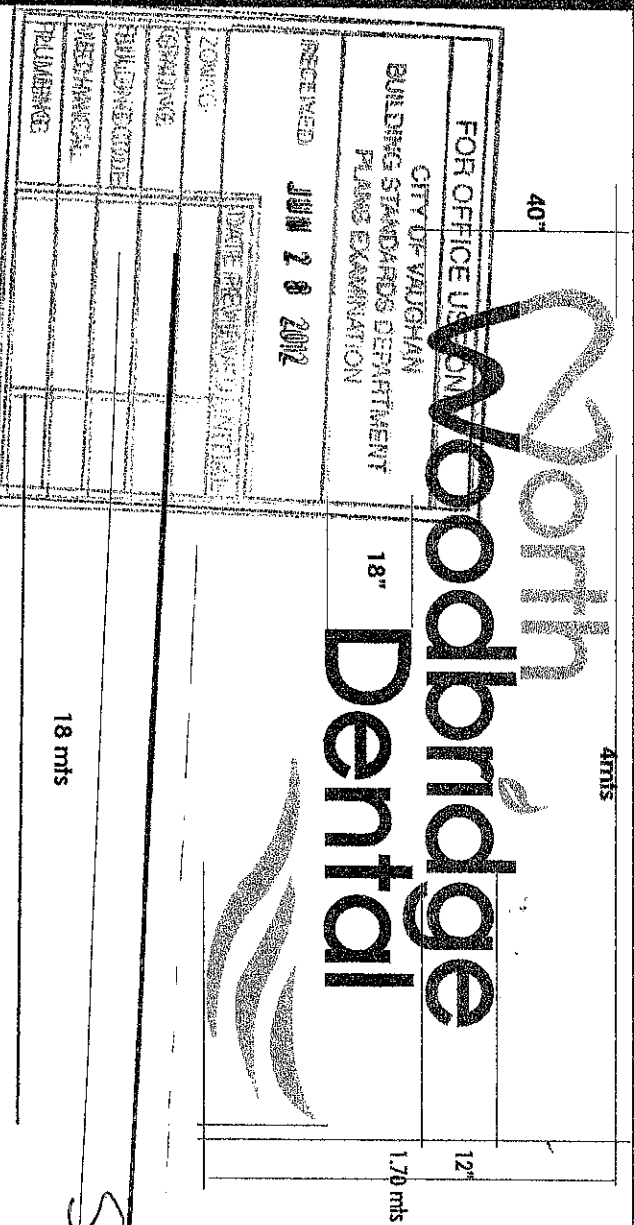

DIMENSIONAL PLAN West Face



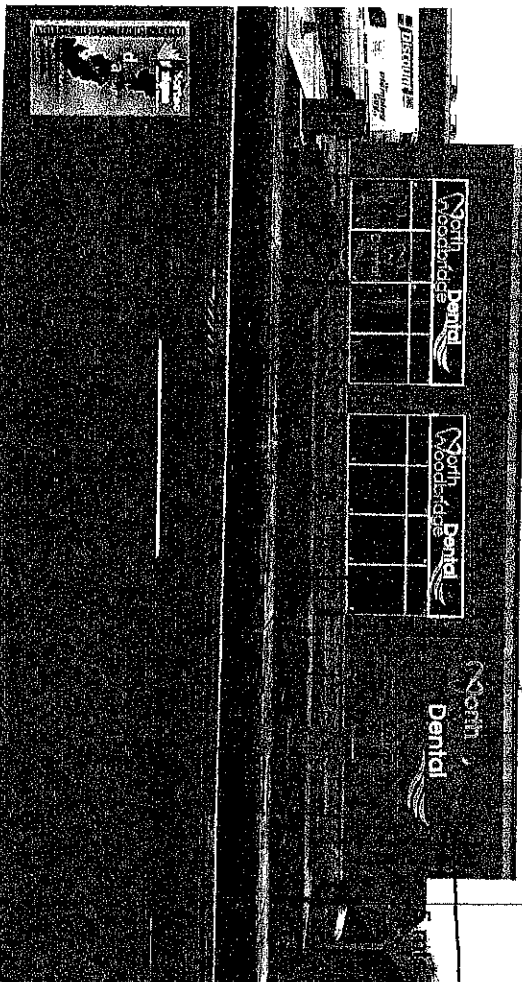

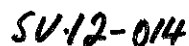
