Analysis and Options

Maxey Valley Bocciofila Club Inc.

MVBC has been using the City's storage facility at Maxey Park since August 1, 2008, for the sole purpose of a bocce equipment storage room.

Per section 46 of their License Agreement the Licensee exercised their one time five (5) year option to renew August 1, 2013 which will be expiring July 31, 2018.

Vaughan Soccer Club Inc.

VSC has been occupying the facility located at 11151 Keele Street, known as the Develin House since November 1, 2006. Their Original License Agreement expired

October 2011 and a new License Agreement was entered into November 1, 2013 for a 5-year term expiring October 31, 2018.

VSC are current with their monthly maintenance fee payments of \$1,393.81 plus HST based on 100% occupancy of the facility.

Financial Impact

Due to the nominal operational cost to the City related to MVBC's use of the storage room at Maxey Park, and the cost to the City of administering any recovery, there is no maintenance fee charged by the City in the agreement with MVBC.

The VSC license fee will offset the expenses the City incurs to maintain services at the Develin House for which VSC has exclusive use. The City will receive compensation for the cost of utilities and maintenance, which includes garbage, cleaning and other basic operating costs where applicable, and which are subject to annual reconciliation.

The agreements with MVBC and VSC will effectively support the partner organizations to meet the community's social, cultural and recreational needs.

Broader Regional Impacts/Considerations

There are no regional implications associated with this report.

Conclusion

The City's standard and past practice has been to permit a direct license to a third party for a nominal fee, provided that the license facilitates the achievement of a specific corporate objective.
