POLICY STATEMENT

A policy providing for restrictions and limitations on the use of mobile devices, and devices capable of taking photographs or videos, at a voting place during a municipal election.

PURPOSE

The *Municipal Elections Act, 1996* (the "Act") makes it an offence to reveal a vote, including taking photographs or videos recording the marked ballot. This policy expands on that principle of secrecy to ensure that electors' voting intentions remain secret and are not revealed directly or indirectly by way of mobile devices or photography or videography at a Voting Place.

SCOPE

This policy applies to all persons present at a Voting Place designated by the City Clerk during a time at which the designated location is actively being used as a Voting Place.

LEGISLATIVE AUTHORITY AND REQUIREMENTS

Municipal Elections Act, 1996:

Powers of clerk

- **12** (1) A clerk who is responsible for conducting an election may provide for any matter or procedure that,
 - (a) is not otherwise provided for in an Act or regulation; and
 - (b) in the clerk's opinion, is necessary or desirable for conducting the election.

1996, c. 32, Sched., s. 12 (1).

Secrecy

49 (1) Every person who is present in a voting place or at the counting of the votes shall help to maintain the secrecy of the voting. 1996, c. 32, Sched., s. 49 (1).

Offences

- (2) No person shall,
 - (a) interfere or attempt to interfere with an elector who is marking the ballot;
 - (b) obtain or attempt to obtain, at a voting place, information about how an elector intends to vote or has voted; or
 - (c) communicate any information obtained at a voting place about how an elector intends to vote or has voted. 1996, c. 32, Sched., s. 49 (2).

Same, revealing a vote

- (3) No elector shall,
 - (a) take a photograph or video recording of his or her marked ballot; or
 - (b) show his or her marked ballot to any person so as to reveal how he or she has voted, except in connection with obtaining assistance in voting under paragraph 4 of subsection 52 (1). 2016, c. 15, s. 36.

No requirement of disclosure

(4) No person shall, in a legal proceeding relating to an election, be required to disclose how he or she voted at the election. 1996, c. 32, Sched., s. 49 (4).

DEFINITIONS

Election Official: A person designated by the City Clerk as an election official in accordance with the Act.

Media: Any person or organization intending to disseminate information to the public through print, radio, television, internet (including blogs) or social media

Mobile Device: A technological device capable of sending and receiving data and taking photographs or recording videos, including but not limited to cellular telephones, tablets and smart watches.

Photography: Taking photographs or recording videos.

Voting Place: A place designated by the City Clerk for the purposes of holding a vote in respect of a municipal election.

POLICY

1. General

- 1.1 The use of Photography or Mobile Devices at a Voting Place by electors, candidates or scrutineers is strictly prohibited except for the purposes of presenting valid original identification to an Election Official where authorized by the City Clerk.
- 1.2 Election Officials are permitted to use Mobile Devices for sending or receiving information or for use as a communication device for purposes pertaining to their election duties.
- 1.3 Election Officials may not take photographs or videos at the Voting Place while it is open for voting.
- 1.4 With the permission of the Managing Deputy Returning Officer, an Election Official who requires use of their Mobile Device for personal reasons may leave the room being used for voting to respond to calls or messages received on that device.

2. Exception

2.1 This policy does not apply to members of the Media governed under other policies established by the City Clerk.
