On Wednesday May 13, 2015, the City of Vaughan Policy Planning Department and the City's lead consultant, Macaulay Shiomi Howson Ltd. will host the first in a series of Public Open House/Workshop meetings with respect to the preparation of the Secondary Plan for Block 27, one of the City's New Community Areas. Block 27 is bordered by Kirby Road to the north, Keele Street to the east, Teston Road to the south and Jane Street to the west. It has an area of approximately 400 hectares (990 acres). The subject lands are shown on the location map provided.

## **PURPOSE OF THE STUDY:**

In accordance with the York Region Official Plan and Vaughan Official Plan 2010, the City of Vaughan is embarking on the preparation of a Secondary Plan for Block 27. The Secondary Plan will provide the policy framework and resulting land use plan to guide the future development of Block 27. Block 27 will be primarily residential with a mix of housing types and densities, and will also include retail stores, restaurants, offices, parks, community facilities, and schools. It will also be planned to incorporate a potential GO Station as part of a Mobility Hub / Local Centre.

## **PURPOSE OF THE MEETING:**

The Visioning Summit will provide those in attendance with information regarding the Block 27 Secondary Plan study process. It will also provide an opportunity to discuss the existing conditions and characteristics of the subject lands, the issues and opportunities respecting the development of the Secondary Plan for the new community, and an opportunity to share your views for a vision of the area. The meeting will include a presentation which will be followed by round table discussions and activities to obtain public input on the vision to guide the planning and development of the New Community Area – Block 27.
