On December 10, 2013, Council approved the recommendation of the Finance and Administration Committee to retain Cole Engineering Incorporated (Cole) to proceed with the detailed design engineering work for the roads, water, wastewater and storm water infrastructure within the Hospital Precinct Development.

# Detailed design is rapidly progressing and it is anticipated that existing road modifications will commence in Summer 2014

Cole is currently carrying out detailed design for the required infrastructure modifications on Major Mackenzie Drive, between Jane Street and Highway 400, as well as the required modifications to the existing ramp connecting the property north of Major Mackenzie Drive to the property south. It is anticipated that a contract for the construction of these works will be tendered in April 2014, with construction being carried out in the Summer and Fall of 2014.

However, in order to continue to provide access to Canada's Wonderland during this construction, temporary modifications will need to be made in advance to the existing driveway within the Hospital Precinct Development.
