## **Economic Impact**

The total estimated cost of the project including contingency allowance and all applicable taxes and administration recovery is \$482,081.23. ### Purpose

The purpose of this report is to award the contract for RFP17-017 Consulting Services for the Development of a Pedestrian and Cycling Strategy for the City of Vaughan to CIMA Canada Inc.

#### **Background - Analysis and Options**

The City's vision, is to be "A City of Choice" that promotes diversity, innovation and opportunity for all citizens, fostering a vibrant community life that is inclusive, progressive, environmentally responsible and sustainable (Vaughan Vision 2020 Strategic Plan).

The development of a new Pedestrian and Cycling Strategy is aligned with Vaughan's city building objective. The Vaughan Official Plan (VOP) 2010 calls for a transportation transformation in how people move around Vaughan by establishing a comprehensive transportation network that allows a full range of mobility options, including walking, rolling, cycling and transit. The new Pedestrian and Cycling Strategy will aim to achieve this transformation and put the City of Vaughan at the fore-front in providing its citizens with accessible, viable, low-carbon walking, rolling and cycling transportation alternatives.

The development of the Vaughan Pedestrian and Cycling Strategy is in support of the 2014-2018 Term of Council's priority to "Continue to develop transit, cycling and pedestrian options to get around the City" and is identified as Key Activity T02.2 Pedestrian and Cycling Strategy.

Both, the 2007 Pedestrian and Bicycle Master Plan Study (PBMP) and the 2012 New Paths Vaughan Transportation Master Plan, recommend that the PBMP Master Plan be updated every five years. Though the network map identified in the PBMP has been updated continuously to reflect network changes, the overall pedestrian and cycling strategy has not been updated since it was first developed in 2007.

Since 2007, and especially over the last five years, there has been significant advancement in the development of active transportation policies and strategies as well as guidelines for the planning, design, implementation and operation of active transportation facilities. A new strategy is necessary to reflect changes in provincial policies and best practices for active and sustainable transportation, as well as to address the needs of our citizens today.

The Terms of Reference for the Pedestrian and Cycle Strategy was prepared between October and December 2016 by Development Engineering and Infrastructure Planning in partnership with Parks Development and Transportation Services, Parks and Forestry Operations (Traffic Engineering). Working together, the projects goals and objectives were identify together with the key deliverables. With input from additional departments across the City, the Terms of Reference, for the Development of the Pedestrian and Cycling Strategy was finalized and included the following high-level deliverables:

1. <u>Generate Community Excitement and Support for Walking and Cycling</u> in the City of Vaughan through a branding and marketing campaign as well as an extensive and robust public and stakeholder engagement strategy.

The RFP package provided details of the contract, including the evaluation criteria used in the assessment of competing proposal bids.

# The City received a total of four (4) proposals for the Development of a Pedestrian and Cycling Strategy for the City of Vaughan.

A total of 12 Plan Takers registered for this RFP, and four compliant bids were received as per below:

The Committee comprised of staff from four City departments under two portfolios that will be involved in developing and executing the Pedestrian and Cycling Strategy. Represented departments included:

- Development Engineering and Infrastructure Planning
- Parks Development
- Transportation Services, Parks & Forestry Operations (Traffic Engineering)
- Policy Planning and Environmental Sustainability

The City's bid package provided details of the contract, including the following criteria to be used in the evaluation of the submissions:

Submissions from the compliant proponents were evaluated and scored based on the above criteria. Evaluation Committee members individually reviewed the compliant proposals between January 24<sup>th</sup>, 2017 and January 30<sup>th</sup>, 2017. On January 30<sup>th</sup>, 2017, the Evaluation Committee met and jointly reviewed each proposal in detail. The entire evaluation process was facilitated by the Procurement Services department.

# Based on the Evaluation Committee's review of the proposals, CIMA Canada Inc. scored the highest ranking.

Based on the Evaluation Committee's review, CIMA Canada Inc. scored the highest and successfully fulfilled the requirements set forth in the RFP. As such, staff recommends the award of contract for RFP17-017 Consulting Services for the Development of a Pedestrian and Cycling Strategy for the City of Vaughan to CIMA Canada Inc.

# It is anticipated that the project will commence at the beginning of Q3-2017 and be completed by end of Q2-2018.

The targeted completion of the study is approximately 12 months. It is anticipated that the project will commence at the beginning of Q3-2017 and be completed by end of Q2-2018.

# Relationship to Term of Council Service Excellence Strategy Map (2014-2018)

## The development of the Pedestrian and Cycling Strategy will support Council's priority to "continue to develop transit, cycling and pedestrian options to get around the City".

In consideration of the strategic priorities set by Council, the recommendations of this report will specifically inform priority:

- T02 Continue to develop transit, cycling and pedestrian options to get around the City. The recommendations contained in this report are consistent with the priorities, advancing the following key activity:
  - T02.2 Pedestrian and Cycling Strategy

However, indirectly it will also inform the following priorities:

- T07 Continue to ensure the safety and well-being of citizens
- T12 Continue to cultivate an environmentally sustainable city

## **Regional Implications**

York Region (Active and Sustainable Transportation) has been identified as a key stakeholder in this study and will be directly involved in the development of the Strategy. The Region will be particularly important in confirming the existing and forecasted pedestrian and cycling network on regional roads, identifying gaps within the overall system and opportunities for integrated links that support transit use improve connectivity between neighborhoods and provide comfortable routes to major destinations.

In addition, the Region is a major partner in providing Regional active transportation infrastructure as well as funding for municipal active transportation infrastructure through the Municipal Partnership Program.

## **Conclusion**

Based on the evaluation committee's review of the proposals submitted in response to RFP17-017 Consulting Services for the Development of a Pedestrian and Cycling Strategy for the City of Vaughan, CIMA Canada Inc. successfully fulfilled all of the City's technical requirements related to the study and scored the highest overall.

As such, staff recommends that the contract for RFP17-017 Consulting Services for the Development of a Pedestrian and Cycling Strategy for the City of Vaughan be awarded to CIMA Canada Inc., in the amount of \$399,945.00, plus applicable taxes.

The total estimated cost of the project including a contingency allowance in the amount of \$60,000.00, all applicable taxes and administration recovery is \$482,081.23. The current budget in approved Capital Project DT-7097-14 Pedestrian and Cycle Strategy is not sufficient to accommodate the total cost of the project; therefore, a capital budget amendment of \$68,000.00 is required. The recommended capital budget increase will be funded from City-wide Engineering Development Charges.

It is anticipated that the Pedestrian and Cycling Strategy will be completed by end of Q2-2018.
