Recommendation

The Chief Financial Officer/City Treasurer and the Director of Financial Services/Deputy City Treasurer in consultation with the Deputy City Manager of Legal Services and Human Resources recommend:

1) That a By-law be enacted to authorized the Mayor and City Clerk to execute a Shared Services Agreement between The City of Vaughan and PowerStream Inc. in a form satisfactory to the Chief Financial Officer/City Treasurer and the City Solicitor.

Contribution to Sustainability

The Shared Services Agreement between the City of Vaughan and PowerStream Inc. provides cost effective services to both organizations.

Economic Impact

The recoveries and costs associated with the proposed shared services agreement were taken into consideration during the 2016 Operating budget process. The impacts will be limited to contractual term adjustments tied to a flat fee increase of 3% for each year of the contract.

Background - Analysis and Options

In 1993 the City of Vaughan and the Vaughan Hydro-Electric Commission entered into a Shared Services Agreement for the purpose of leveraging functional expertise, generating synergies through the sharing of support services, and the benefits of economies of scale. As a result both organizations have attained financial benefits from this partnership that would not exist otherwise. This shared services arrangement continues today with PowerStream Inc.

The agreement with PowerStream Inc. must comply with the Ontario Energy Board's Affiliate Relationship Code. Therefore the pricing and costing methodology will be based on the guidelines set out in the Affiliate Relationship Code. One intended purpose of the Code is to minimize cross subsidization and enhance the development of open competitive market pricing. This is accomplished by establishing pricing guidelines at either fair market value or, if not available, pricing at cost plus the utility's rate of return.
