PLACES TO GROW IMPLEMENTATION FUND

Recommendation

The Chief Financial Officer and City Treasurer recommends:

1. That staff be authorized to submit an application package in support of the Places to Grow Implementation Fund; and
2. That upon notification of grant award, the City Clerk be authorized to execute any necessary agreements in a form satisfactory to the City Solicitor.

Green Directions Vaughan embraces a Sustainability First principal and states that sustainability means we make decisions and take actions that ensure a healthy environment, vibrant communities and economic vitality for current and future generations. Under this definition, activities which promote innovative practices to assist with effective growth planning contribute to the sustainability of the City.

Economic Impact

Staff are proposing to submit an application with a total cost of up to \$70,000 with potential provincial funding of up to \$40,000 under this stream. The City's portion of the project costs would be absorbed within the 2017 operating budget.
