- That the \$60,000 available in Capital Project, Highway 7 Implementation Policy Study (9822-0-03), be re-purposed to Capital Project, Vaughan Official Plan Review (PL-9003-07), to provide funding for additional detailed urban design policies and guidelines to address stakeholder requests for proposed modifications to the Vaughan Metropolitan Centre (VMC) Secondary Plan;
- 2. That the Scope of Work for the VMC Implementation Policies and Detailed Built Form and Public Realm Guidelines be prepared by staff; and,
- 3. That a Scope of Work be issued as per the City's purchasing policies.

The additional policies and guidelines will contribute to the creation of complete communities, including environmentally sustainable aspects such as green and intensified built form, design excellence, transportation demand management measures, and transit and pedestrian supportive environments.

The VMC Secondary Plan is proposed to be modified to reflect the new location for the new bus terminal and to reflect other technical and planning inputs arising through stakeholder consultation towards finalization of the Secondary Plan. More detailed guidance and demonstration is needed on architecture, the buildings' relationship to the public realm, appropriate building to street solutions associated with the different building typologies, and block development in terms of building placement, servicing and open space configurations.

Staff recommend that this additional work be undertaken immediately so that it can be integrated with and inform ongoing modifications to the VMC Secondary Plan, which will be brought forward to a Committee of the Whole meeting in the fall of 2012.
