1. 10391 ISLINGTON AVENUE – PROPOSED ADDITION TO KLEINBURG PUBLIC SCHOOL – WARD 1

Recommendation

 - i. That proposed building materials be reviewed and approved by Cultural Services staff.
- 2) That the applicant be advised that if there are any new changes to the application (eg. Coverage, height, building elevation, site plan) as a result of addressing issues from review by other departments, a new submittal for review for the Heritage Vaughan Committee may be required and any previous approval granted may be deemed invalid based on the new information provided.

Purpose

To review the proposed addition to the Kleinburg Public School at 10391 Islington Avenue.

Background - Analysis and Options

Background

The subject property is located on the east side of Islington Avenue, north of the McMichael Art Gallery. The subject property is located in the Kleinburg-Nashville Heritage Conservation District and, as such, is designated Part V of the Ontario Heritage Act.

The original school on the subject property was constructed in 1955 in the Modern Movement style. The current school on the subject property was constructed in 2009 and evoked the same Modern Movement style.

Analysis of the design

- Section 9.2.2 of the Kleinburg Nashville Heritage Conservation Districts classifies the Modern Movement as a non-heritage style. The existing school and proposed addition both relate to this style and therefore is an acceptable addition to the building.
- Section 9.4.1.2 discusses the Contemporary Alteration option when work is proposed for nonheritage style buildings. The proposed addition utilizes this option.
- The original design intended for this addition to be included, however, it was never realized. The space where the addition will be placed is mostly void of windows.
- The proposed addition will use the same materials, wherever possible, as the existing school building.
