## AMENDMENT TO THE OFFICIAL PLAN PROPOSED MAPLE GO STATION SECONDARY PLAN (File 26.8)

### COMMITTEE OF THE WHOLE (PUBLIC HEARING)

**PROPERTY:** The lands subject to the study are located within the Maple Community on the south side of McNaughton Road East, west of Troon Avenue, north of Hill Street, and east of the existing Maple GO Station. (See reverse for map.) STUDY: The Vaughan Official Plan 2010 (VOP 2010) requires the preparation of a Secondary Plan (Official Plan Amendment) to permit the development of the subject lands in accordance with the "Mid-Rise Mixed-Use" designation of VOP 2010. In 2011, the City of Vaughan received an application from the proponent (York Major Holdings Inc.) for approval of a Secondary Plan to permit the future development of the subject lands as shown on the attached map. A public open house was held on September 13, 2012 at which time the plan was presented by the proponent. The presentation was followed by a discussion of the opportunities and constraints respecting the future development of the lands. The later version of the plan attached is reflected in the following statistics: 235 townhouse units within 45 townhouse blocks of which 12 will be block townhouses with a private lane and the remaining 33 blocks will be street townhouses on a public road; and, . 783 residential units within 5 mid-rise apartment buildings, ranging in height from 6 - 12 storeys, as shown on Attachments #3 - #6. A separate report on the proposed official plan and zoning by-law amendment and draft plan of subdivision will also be on the agenda at this Committee of the Whole Public Hearing (May 21, 2013) Meeting. #### <u>NOTE</u>

#### Official Plan (O. Reg. 543/06)

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted the person or public body is not entitled to appeal the decision of The City of Vaughan or The Regional Municipality of York, as the case may be, to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

If you wish to be notified of the adoption of the proposed Official Plan Amendment, or of the refusal of a request to amend the official plan, you must make a written request to the City of Vaughan, City Clerk's Office, 2141 Major Mackenzie Drive, Vaughan, Ontario L6A 1T1.
