NORTH MAPLE COMMUNITY BRIDGE CLASS ENVIRONMENTAL ASSESSMENT STUDY


PROCESS

The City of Vaughan, in conjunction with AECOM has completed a Class Environmental Assessment (EA) Study for the proposed North Maple Community Bridge located in City Block No. 33 as shown on the location map. This study was conducted in accordance with the requirements of a Schedule 'C' Study under the Municipal Engineers Association's Municipal Class Environmental Assessment (October 2000, as amended in 2007 and 2011). The Environmental Study Report and its findings are now available for public viewing and comment.

Public and external agency consultation was a key component of this Study. Two Public Information Forums (PIFs) were held to provide interested stakeholders with opportunities to meet the project team and to discuss alternative solutions, environmental considerations / impacts, evaluation criteria, and design options. In addition to the PIFs, a Citizen's Liaison Committee was established to obtain input from individual interest groups, agencies, ratepayers, and property owners at key stages of the Study.

PREFERRED SOLUTION

The Class EA Study has determined the preferred preliminary design of the proposed Highway 400 overpass connecting Canada Drive to America Avenue. Implementation of the project will allow for the construction of a local multi-modal transportation connection across Highway 400 which includes sidewalks, bicycle lanes and two vehicular travel lanes.



PUBLIC COMMENT INVITED

An Environmental Study Report (ESR) has been prepared for this project. The report describes the problem, the assessment of alternatives and the preferred solution, as well as the public and agency consultation completed during the Study. This Notice places the ESR on record for public review starting **December 12**th, **2013** at the following locations during regular business hours:

Anyone with an interest in the Study is encouraged to review the ESR and provide comments to the City of Vaughan during the designated review period. If any concerns cannot be resolved by the City of Vaughan, a request can be made to the Minster of the Environment for the project to comply with Part II of the Environmental Assessment Act (referred to as a Part II Order). A request for a Part II Order must be received by the Minister at the address below, by **February 3rd**, **2014**. A copy of the request must also be sent to the City of Vaughan Project Manager. If no request is received by **February 3rd**, **2014**, the Schedule 'C' recommended preferred solution will be approved.
