

NOTICE OF PUBLIC OPEN HOUSE - NOVEMBER 4, 2013 THE DRAFT CONCORD GO CENTRE SECONDARY PLAN (File 26.3)

The purpose of this Public Open House is to present the draft Concord GO Centre Secondary Plan in order to obtain Public input prior to its finalization. Opportunity for comment will also be provided at a Public Hearing Meeting before the Vaughan Committee of the Whole, which will take place at a later date. Notice of the Public Hearing Meeting will be provided separately.

PROPERTY:

The lands subject to the Secondary Plan Study are generally centered on the intersection of Highway 7 and the Barrie GO Rail line and are bounded on the north by Rivermede Road; on the north west by Bowes Road, on the southwest by the Barrie GO Rail line and on the south and east by the Hydro Corridor. (See enclosed map.)

PURPOSE:

The Vaughan Official Plan 2010 (VOP 2010) requires the preparation of a Secondary Plan (Official Plan Amendment) to permit the development of the subject lands in accordance with the "Local Centre" policies of the VOP 2010. The Secondary Plan builds on the general land use policies identified in Volume 1 of VOP 2010 and will provide more detailed policies to guide development of the Concord GO Local Centre to the year 2031. The Local Centre policies provide for the creation of a new mixed-use (residential/commercial) community focus and potential transportation hub, which may include mid-rise or high-rise buildings as appropriate. The plan will also address policies in regard to the type and density of land uses, the provision of infrastructure, development phasing, parks and pedestrian trails, urban design and the environment. The role of the adjacent Employment Areas will also be examined.

PROPONENT: The Concord GO Centre Secondary Plan Study is a City of Vaughan initiated

Study.

NOTE Official Plan (O. Reg. 543/06)

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted the person or public body is not entitled to appeal the decision of The City of Vaughan or The Regional Municipality of York, as the case may be, to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

If you wish to be notified of the adoption of the proposed Official Plan Amendment, or of the refusal of a request to amend the official plan, you must make a written request to the City of Vaughan, City Clerk's Office, 2141
