



## Blue Willow Area: Road Rehabilitation

### PROJECT UPDATE

The City of Vaughan's 2021 Road Resurfacing and Rehabilitation Project is scheduled to commence the week of April 19, 2021. This is a multi-phased initiative to rehabilitate community roads and make needed repairs to existing curbs and sidewalks. This project is anticipated to be completed by December 2021.

### PLANNED CONSTRUCTION WORK

The scope of work under this contract will include road rehabilitation and replacement of isolated areas of sidewalk and curb.

### CONSTRUCTION IMPACTS

Property owners are reminded that underground systems, such as lawn sprinklers, heated driveways, and electrical conduits etc., within City-owned boulevards or property limits may be impacted by the proposed construction work. **At the property owner's discretion and where possible, the removal of such privately-owned underground systems in advance of construction may be prudent.** The City is not responsible for any damages that may occur during construction to privately-owned items that are within City-owned property limits (Encroachment By-law No. 034-2017). Please refer to the drawing on the back of this newsletter illustrating the property line location.

Roads will remain open to vehicular and pedestrian traffic during construction. Temporary lane restrictions will be required to allow for construction activities to proceed in a safe and efficient manner.

Access to private driveways will be impacted at times during localized curb replacement and associated restoration works.

Your waste collection day will not change during construction.
