- 2. That Part C and D of Tender T16-169 Supply and Delivery of Vehicles be awarded to Georgian Chevrolet Buick GMC in the amount of \$382,350.00 (Part C \$115,600.00, Part D \$266,750.00) plus provisional items in the amount of \$4,984.00 and any applicable taxes;

Residual funding in capital project FL-5468-16- PW-WATER-Replace Unit #1563 with 3/4 ton cargo van, is available to offset this shortfall. The capital project budget amendments associated with this funding transfer are outlined in Attachment #1.

Staff have reviewed the bids for mathematical errors and are satisfied the lowest bidders of parts A, B, C and D meet the specifications. The award does not exactly match the bids submitted due to the procurement of provisional items.

Total provisional items of \$15,655.00 in Parts A and B include Bluetooth and rear-camera features on all vehicles, as well as side steps for all pick-up trucks for improved safety. The total also includes operational accessory needs such as 4x4 and a plow attachment required to meet the vehicle specifications in the approved capital projects.

Total provisional items of \$4,984.00 in Part C include Bluetooth and rear-camera features on all vehicles.

Capital project budget increases were principally due to increases in pricing versus outdated capital estimates (dating back to 2014), the addition of bluetooth and backup camera safety equipment, and updated user specifications.
