## THE APPLICATION PROCESS

This package contains the necessary application to apply for the **Driving school (vehicle) owner/ instructor, Driving school (vehicle) owner or Driving school instructor** in the City of Vaughan (the City). To apply,

#### How to apply

Applicants and licensees have four options for submitting new or renewal licence applications:

- Licensing Portal where you can apply online for and renew many licences, posted at vaughan.ca/BusinessLicensing. Note, you will not be required to complete this form if you apply using the portal.
- 2. Mail to "Attn: By-law and Compliance, Licensing and Permit Services Department".
- **3. Drop off** to drop-boxes located at the entrances of Vaughan City Hall, with the enveloped marked, "Attn: By-law and Compliance, Licensing and Permit Services".
- **4. By e-mail** to <a href="mailto:bylaw.licensing@vaughan.ca">bylaw.licensing@vaughan.ca</a>, along with scanned copies of required documentation, and an e-mail indicating a contact phone number for staff to collect payment.
