## What improvements are being made?

The City of Vaughan is undertaking important municipal infrastructure improvements in the Old Maple area, including watermain replacement, drainage improvements, storm sewer enhancements and road reconstruction work. These enhancements support the City's continued commitment to ensuring long-term sustainability of municipal infrastructure.

Construction is expected to start in spring 2022, with anticipated completion by summer 2023.

# Join the conversation


In February 2021, the City hosted several virtual Public Information Centres to inform local residents and stakeholders about the project, including proposed improvements, timelines and impacts on the community. Participants also viewed maps and drawings and had the opportunity to ask the project team questions.

Now, the City is inviting you to participate in an online survey to collect information about any known stormwater drainage and sump pump piped discharges, specifically if these pipes discharge directly into the existing ditch system, near your home or business. This information will help the City ensure these pipes are accounted for in the design and not be obstructed during construction. As well, City staff need to account for private sprinkler systems, heated driveways, private electrical conduits, non-visible fencing or any other underground features that may encroach onto the municipal boulevard.

Property owners are reminded that underground systems, such as lawn sprinklers, heated driveways, electrical conduits, or landscaping, etc., within City-owned boulevards or property limits, may be impacted by the proposed construction work. **Removing privately owned underground systems in advance of construction, at the owner's expense, is recommended.** The City is not responsible for any damages that may occur during construction to privately-owned items within City property limits (Encroachment By-law No. 034-2017).



#### **Construction scope**

Construction will include replacement of existing watermains and road rehabilitation, as identified in the areas of the blue dotted lines on the map. The project scope has been expanded to include stormwater drainage improvements, which will include regrading and reinstatement of the existing ditches within the project limits to ensure maximum drainage capacity is achieved and reduce flood risk. The installation of new storm sewers along a portion of Church Street, Gram Street and Naylon Street is also included.
